1 **NOTICE IS HEREBY GIVEN** that Defendant Blue Coat Systems, Inc. ("Blue Coat") 2 in the above-captioned action further appeals to the United States Court of Appeals for the 3 Federal Circuit from this Court's Corrected Judgment entered on August 19, 2016 (Dkt. 556) and 4 Judgment entered on November 20, 2015 (Dkt. 487), and all rulings, proceedings, orders, and 5 decisions adverse to Blue Coat including but not limited to the Court's Order Regarding Judgment (Dkt. 555), Order Regarding Post-Judgment Motions (Dkt. 543), Order Regarding 6 7 Non-Jury Legal Issues (Dkt. 486), Order on *Daubert* Motions (Dkt. 378), Order on Parties' 8 Motions In Limine and Pretrial Orders (Dkt. 367), Order Granting in Part Defendant's Motion to 9 Strike Infringement Theories (Dkt. 271), Order Granting in Part and Denying in Part Defendant's 10 Motion for Summary Judgement (Dkt. 256), the Order Construing Claims (Dkt. 118), and all 11 pre-trial and trial evidentiary rulings.
