#### **NOTICE OF APPEAL**

Notice is hereby given that Teva Pharmaceuticals USA, Inc. and Teva Pharmaceutical Industries Ltd., defendants in this case, appeal to the United States Court of Appeals for the Federal Circuit from the Supplemental Opinion entered in this action on March 3, 2016 (Dkt. 381), together with all earlier and later orders, rulings, and findings, including without limitation this Court's Outline of Supplemental Opinion and Text Order (Dkt. 382, 383). The Supplemental Opinion merely elaborates on the original opinion and separate "final judgment" that has already been appealed by the same appellants. *See* Case No. 16-1284 (Fed. Cir.).
