**NOTICE OF CROSS-APPEAL**

NOTICE is hereby given that Plaintiff Hospira, Inc. (“Hospira”) hereby cross-appeals to the United States Court of Appeals for the Federal Circuit from the portions of the February 6, 2018, Judgment (D.I. 121) and the January 22, 2018, Memorandum (D.I. 119) holding invalid certain asserted claims (*i.e.*, all asserted claims other than Claim 6 of U.S. Patent No. 8,648,106), and any other decision or order adverse to Hospira.

In accordance with Rule 4(a)(3) of the Federal Rules of Appellate Procedure, Hospira files this Notice of Cross-Appeal within 30 days after entry of the February 6, 2018, Judgment. On February 6, 2018, the Court of Appeals for the Federal Circuit docketed Amneal Pharmaceuticals’ appeal as Case No. 18-1522.
