NOTICE OF APPEAL

1 Plaintiff Cave Consulting Group, Inc. (“CCGroup”) hereby appeals to the United States
2 Court of Appeals for the Federal Circuit the District Court’s Order Granting in Part Defendant’s
3 Motion for Attorneys’ Fees and Nontaxable Expenses Pursuant to 35 U.S.C. § 285 (ECF No. 365)
4 entered March 14, 2018.

5 CCGroup notes that the District Court has instructed the parties to further brief the issue
6 of the proper determination of the amount of fees to be awarded. Briefing on the issue is not yet
7 complete. In an abundance of caution, however, CCGroup is filing this Notice to preserve its
8 right to appeal.

9 This Notice of Appeal relates to the appeal that has been docketed in the Federal Circuit
10 as Docket No. 18-1488, which relates to the District Court’s Order Granting Defendant’s Motion
11 for Summary Judgment (ECF No. 342), entered December 15, 2017, and the ensuing Judgment
12 (ECF No. 345) entered January 4, 2018.
