**DEFENDANT ABHAI, LLC'S NOTICE OF APPEAL**

Pursuant to Fed. R. App. P. 3 and 28 U.S.C. § 1291, notice is hereby given that Defendant Abhai, LLC ("Abhai") appeals to the United States Court of Appeals for the Federal Circuit from the following orders, rulings, and judgments of the District Court for the District of Massachusetts in the above captioned case:

1. The March 22, 2018 Findings of Fact, Rulings of Law and Order for Judgment finding that the product that Abhai intends to market under its Abbreviated New Drug Application No. 207489 ("Abhai's ANDA Product") infringes claim 1 of United States Reissued Patent RE42,096 under 35 U.S.C. § 271(e)(2)(a) and infringes claims 1, 11, and 13 of United States Reissued Patent RE41,148 patent under 35 U.S.C. § 271(e)(2)(a) (Doc. No. 337).
2. The March 22, 2018 Findings of Fact, Rulings of Law and Order for Judgment finding that Abhai engaged in litigation misconduct warranting sanctions (Doc. No. 337).
3. The March 22, 2018 Judgment for Plaintiffs against the Defendant (Doc. No. 338).

4. Any and all orders, rulings, and judgments underlying the foregoing, and any and all interlocutory judgments, decrees, decisions, rulings, findings, instructions, opinions, and proceedings of the Court adverse to Abhai that were rendered before the Court's entry of Final Judgment, whether or not they were specifically docketed.
