DEFENDANT ABHAI, LLC’S NOTICE OF APPEAL

Pursuant to Fed. R. App. P. 3 and 28 U.S.C. § 1291, notice is hereby given that Defendant Abhai, LLC (“Abhai”) appeals to the United States Court of Appeals for the Federal Circuit from the following order of the District Court for the District of Massachusetts in the above captioned case: the July 11, 2018 Memorandum and Order awarding \$1,501,455.32 in costs and fees to Plaintiffs (Dkt. No. 360) and any and all orders, rulings, and judgments underlying the foregoing, and any and all interlocutory judgments, decrees, decisions, rulings, findings, instructions, opinions, and proceedings of the Court adverse to Abhai that were rendered before the Court’s entry of Final Judgment, whether or not they were specifically docketed.¹

¹ On April 20, 2018, Abhai filed a Notice of Appeal regarding: (1) this Court’s March 22, 2018 Findings of Fact, Rulings of Law and Order for Judgment (Dkt. No. 337); (2) the March 22, 2018 Judgment for Plaintiffs against the Defendant (Dkt. No. 338); and (3) any and all orders, rulings, and judgments underlying the foregoing. (See Dkt No. 344.) That appeal was docketed in the Court of Appeals for the Federal Circuit on April 23, 2018 and is now pending as Shire LLC v. Abhai LLC, No. 18-1866. Abhai respectfully requests that the Court of Appeals for the Federal Circuit consolidate the instant appeal with the pending appeal (No. 18-1866).
