Upon information and belief, Defendant directly or through intermediaries has been and is now infringing the '685 Patent in the State of California, in this judicial district, and elsewhere in the United States, by, making, using, providing, supplying, distributing, selling, and/or offering for sale products (including at least its website at www.feit.com) further including its smart wifi enabled color changing lights and similar type assemblies, comprising a light source that infringes one or more claims of the '685 Patent and particularly, e.g., claims 10 through 14 of the '685 Patent. The '685 Patent reads on Feit's wifi enabled smart lights as set forth in the exemplary claims chart attached as **Exhibit B**.
