**NOTICE OF APPEAL**

26 PLEASE TAKE NOTICE that Defendant Power Integrations, Inc. in the above-named  
27 case hereby appeals to the United States Court of Appeals for the Federal Circuit from the Order  
28 Re Post-Trial Motions (Dkt. No. 336) and the “Final Judgment” (Dkt. No. 346), each to the extent

1 the District Court did not adopt Defendant’s arguments and positions (including the District  
2 Court’s award of damages), and from all decisions, rulings and orders that gave rise to the non-  
3 adoption of Defendant’s arguments and positions in the Order Re Post-Trial Motions and “Final  
4 Judgment,” including without limitation the District Court’s claim construction order (Dkt. No.  
5 58) and its denials of Defendant’s motions to exclude Plaintiff’s damages case and evidence  
6 offered in support thereof before and during trial.

7 Defendant also notes that it should be re-designated Appellant, with Plaintiff designated as  
8 Cross-Appellant, since liability was found and Plaintiff’s appeal only seeks an increase in the  
9 amount of damages.
