(collectively, “TCL”) and adverse to IP Bridge, and from any and all underlying and/or interlocutory orders, findings, determinations, conclusions, opinions, or decisions of the District Court in favor of TCL and adverse to IP Bridge relating to, pertinent to, or ancillary to that Final Judgment, including, but not limited to, the District Court’s Memorandum Order Regarding Claim Construction dated April 19, 2017 (D.I. 234).
