**NOTICE OF CROSS-APPEAL TO THE UNITED STATES
COURT OF APPEALS FOR THE FEDERAL CIRCUIT**

Notice is hereby given that, pursuant to Federal Rule of Appellate Procedure 4(a)(3), Plaintiff SIMO Holdings, Inc. (“SIMO”) hereby cross appeals to the United States Court of Appeals for the Federal Circuit from the October 16, 2019 Amended Judgment (Dkt. 280) entered by the District Court in this action, and from any and all underlying and/or interlocutory decisions, opinions, orders, findings, or conclusions of the District Court adverse to SIMO.

In particular, SIMO cross appeals the calculation of compensatory damages awarded by the District Court in the October 16, 2019 Amended Judgment (Dkt. 280).

This is a cross-appeal of Defendants Hong Kong uCloudlink Network Technology Limited, and Ucloudlink (America), Ltd.’s second supplemental appeal to the United States Court of Appeals for the Federal Circuit, filed on October 21, 2019 and docketed as Case No. 19-2411. In accordance with Fed. R. App. P. 4(a), this Notice of Cross-Appeal is being filed within 14 days of the filing of Defendants’ Second Supplemental Notice of Appeal and within 30 days after entry of the judgment or order appealed from.

Finally, SIMO notes that proceedings continue in the district court as to whether uCloudlink's products should remain enjoined. SIMO accordingly reserves the right to further modify or supplement its notice of Cross-Appeal should further action by the Court so necessitate.
