- 86. The operation of Defendants' on-line, interactive gaming websites directly infringes the claims of the patent in suit in violation of 35 U.S.C. § 271(a).

- 87. The defendants have also induced and contributed to the infringement of the claims of the '865 patent by others.
 - 88. Defendants' infringement has caused irreparable injury to Lottotron.

PRAYERS FOR RELIEF

WHEREFORE, Lottotron respectfully requests the following relief:

- 1. That Defendants be found by this Court to infringe the '865 patent;
- 2. That the Court award Lottotron its damages in accordance with 35 U.S.C. § 284;
- 3. That the Court award Lottotron its costs, including attorneys' fees, and an assessment of interest;
- 4. That the defendants, their agents, officers, sales representatives, servants, employees, representatives, associates, attorneys, successors and assigns, and any and all persons or entities acting by, through, under, or in concert, privity or in participation with, any or all of them, be permanently enjoined by Order of this Court from doing, abiding, causing, aiding or abetting any of the following:
 - (a) directly or indirectly infringing, or inducing or causing any person or entity to infringe the '865 patent; or
 - (b) contributing to the infringement of the '865 patent; or
 - (c) from assisting, aiding or abetting any other person or entity from engaging in or performing any of the above-described acts.
- 5. That the Court issue an order directing the defendants to provide proof that they have ceased infringing the '865 patent;

- 6. That the defendants be directed to pay over to Lottotron all damages suffered by Lottotron as a result of the defendants' acts herein complained of;
 - 7. That the Court find this case to be exceptional; and
- 8. That the Court grant such other and further relief as it deems just and proper.

JURY DEMANDED

Lottotron hereby demands a trial by jury on all issues so triable.
