NOTICE IS GIVEN that Plaintiff Ironworks Patents LLC (“Ironworks”) appeals to the United States Court of Appeals for the Federal Circuit from the Final Judgment entered in this action on November 22, 2019 (Dkt. No. 178) and from any and all intermediary orders preceding entry of judgment, including without limitation, the Order entered on November 15, 2018 (Dkt. No. 173), the Court’s Claim Construction Order (Dkt. No. 166), Orders granting Defendants’ Motion to transfer case (Dkt. No. 53 and 54), Orders Denying Motion to Transfer (Dkt. Nos. 95 and 98), and Order Denying Plaintiff’s Motion to Dismiss Non-Infringement Counterclaims 1-3 (Dkt. No. 159).

On November 4, 2019, the United States Court of Appeals for the Federal Circuit Ordered, in relevant part, as follows:

The motion to voluntarily dismiss is granted. Each side shall bear its own costs. If Ironworks timely files another notice of appeal from this action, and that filing occurs within 60 days from the date of this order, then the filing fee will be waived. Ironworks is directed to attach a copy of this order to that notice of appeal. The appeal will receive a new docket number, and the current briefs will be applied to the new appeal.
