COMPLAINT FOR PATENT INFRINGEMENT

PARTIES

- Plaintiff Cedar Lane Technologies Inc. is a corporation organized and existing under the laws of Canada that maintains its principal place of business at 560 Baker Street, Suite
 Nelson, BC V1L 4H9.
- 2. Defendant ZTE (USA) Inc. is a corporation organized and existing under the laws of New Jersey that maintains an established place of business at 2425 N Central Expy Suite 800, Richardson, TX 75080.

JURISDICTION

- 3. This is an action for patent infringement arising under the patent laws of the United States, Title 35 of the United States Code.
- 4. This Court has exclusive subject matter jurisdiction under 28 U.S.C. §§ 1331 and 1338(a).

5. This Court has personal jurisdiction over Defendant because it has engaged in systematic and continuous business activities in this District. As described below, Defendant has committed acts of patent infringement giving rise to this action within this District.

VENUE

6. Venue is proper in this District under 28 U.S.C. § 1400(b) because Defendant has committed acts of patent infringement in this District, and has an established place of business in this District. In addition, Cedar Lane has suffered harm in this district.

JURY DEMAND

56. Under Rule 38(b) of the Federal Rules of Civil Procedure, Cedar Lane respectfully requests a trial by jury on all issues so triable.

PRAYER FOR RELIEF

WHEREFORE, Cedar Lane respectfully requests the following relief:

- A. A judgment that the '527 Patent is valid and enforceable;
- B. A judgment that the '242 Patent is valid and enforceable;

- C. A judgment that the '223 Patent is valid and enforceable;
- D. A judgment that the '805 Patent is valid and enforceable;
- E. A judgment that Defendant has infringed, contributorily infringed, and/or induced infringement of one or more claims of the '527 Patent;
- F. A judgment that Defendant has infringed, contributorily infringed, and/or induced infringement of one or more claims of the '242 Patent;
- G. A judgment that Defendant has infringed, contributorily infringed, and/or induced infringement of one or more claims of the '223 Patent;
- H. A judgment that Defendant has infringed, contributorily infringed, and/or induced infringement of one or more claims of the '805 Patent;
- I. An accounting of all damages not presented at trial;
- J. A judgment that awards Cedar Lane all appropriate damages under 35 U.S.C. § 284 for Defendant's past infringement, and any continuing or future infringement of the Patents-in-Suit, up until the date such judgment is entered, including pre- or post-judgment interest, costs, and disbursements as justified under 35 U.S.C. § 284 and, if necessary, to adequately compensate Cedar Lane for Defendant's infringement, an accounting:
 - i. that this case be declared exceptional within the meaning of 35 U.S.C. § 285
 and that Cedar Lane be awarded its reasonable attorneys' fees against
 Defendant that it incurs in prosecuting this action;
 - ii. that Cedar Lane be awarded costs, and expenses that it incurs in prosecuting this action; and

iii. that Cedar Lane be awarded such further relief at law or in equity as the Court deems just and proper.
