NOTICE OF APPEAL

Plaintiff AgroFresh Inc., pursuant to Rule 3 of the Federal Rules of Appellate Procedure, hereby gives notice that Plaintiff appeals to the United States Court of Appeals for the Federal Circuit from (1) the Memorandum Opinion and Order dated November 30, 2020 (D.I. 639 & 640), which denied AgroFresh’s motion for enhanced damages (D.I. 587), granted with modification AgroFresh’s motion for pre- and post-judgment interest (D.I. 589), and granted-in-part and denied-in-part Defendants’ renewed motion for judgment as a matter of law (D.I. 596), (2) the Amended Judgment entered on December 9, 2020 (D.I. 644), and (3) the Final Judgment entered on December 18, 2020 (D.I. 654). The District Court entered partial final judgment pursuant to Federal Rule of Civil Procedure 54(b) on December 18, 2020 (D.I. 654).

The United States Court of Appeals for the Federal Circuit has jurisdiction over this appeal pursuant to 28 U.S.C. § 1295, as the judgment below is a final decision in a civil action arising under the patent laws. This Notice is filed within thirty (30) days of the entry of the final judgment.
