**AMAZON’S NOTICE OF APPEAL PURSUANT TO
FEDERAL RULES OF APPELLATE PROCEDURE 3 AND 4**

Pursuant to Rules 3 and 4 of the Federal Rules of Appellate Procedure, Defendants Amazon.com, Inc. and Amazon.com, LLC (collectively “Amazon”) respectfully appeal to the United States Court of Appeals for the Federal Circuit from (i) the April 14, 2021 Order denying Amazon’s Motion for Judgment as a Matter of Law of Non-Infringement under Rule 50(b) and Amazon’s Motion for Additional Findings Regarding Inequitable Conduct and to Amend or Alter the Judgment (Dkt. No. 343, attached as Exhibit B), (iii) the December 10, 2020 Sealed Order Regarding the Defense of Inequitable Conduct Together with Supporting Findings of Fact and Conclusions of Law (Dkt.
