COMPLAINT FOR PATENT INFRINGEMENT AND COPYRIGHT INFRINGEMENT

TO THE HONORABLE JUDGE OF THIS COURT:

COMES NOW, Plaintiff, **Aacraft, Inc.**, by and through its/their/her attorney of record, Moster Craft, P.C., files this Complaint for Patent Infringement and Copyright Infringement against Defendant, **JameslyCR**, Owner: John Jamesly Charles, Address: 4391 NW 19th St. Apt 369, Lauderhill, Florida 33313, Registered Agent: Legalinc Corporate Services Inc., Address 10601 Clarence Dr. Ste. 250, Frisco, Texas 75033 (hereinafter referred to as Defendant, JameslyCR). Plaintiff alleges and shows this Honorable Court as follows:

I. JURISDICTION AND VENUE

1. This is an action for patent infringement arising under 35 U.S.C. §251 *et. seq.* and an action for copyright infringement arising under 17 U.S.C. §501 *et. seq.*
2. This Court has original jurisdiction over these actions under 35 U.S.C. §251 *et. seq.*, 17 U.S.C. §501 *et. seq.*, and 28 U.S.C. §§1331 and 1338.
3. Venue in this District is proper under 28 U.S.C. §1391(b) in that a substantial part of the events giving rise to these claims occurred in this judicial district, and under 28 U.S.C.

§1400(b) in that is a judicial district where Defendant has committed acts of patent infringement and copyright infringement and has a regular established place of business.

II. THE PARTIES

4. Plaintiff, Aacraft, Inc., is a Texas for Profit Corporation with an address at 221 Buck Bend, Georgetown, TX 78628 and does substantial business in Georgetown, TX, the State of Texas, and throughout the United States.
5. Defendant, JameslyCR, Owner: John Jamesly Charles, Address: 4391 NW 19th St. Apt 369, Lauderhill, Florida 33313, Registered Agent: Legalinc Corporate Services Inc., Address 10601 Clarence Dr. Ste. 250, Frisco, Texas 75033.
6. Upon information and belief, Defendant uses registered key words such as, “picture hanging tool,” “picture hanging kit,” “picture hanging device,” and “picture hanging,” which are intended to attract web traffic to its sites and infringing products (the “Infringing Products”).
7. Upon information and belief, Defendant, by and through the use of its Infringing Products for sale on Amazon, transacts extensive and substantial e-commerce business in Texas, to Texas residents, and across the United States.

III. FACTS

8. Plaintiff, Aacraft, Inc., owns a design patent for a picture hanging toolkit. The design patent number is US D895,455 S (herein after “the D455 patent”). The patent was issued on September 8, 2020 to Shari Michelle Hammond who has assigned the D455 patent to Plaintiff, Aacraft, Inc.

9. Plaintiff, Aacraft, Inc., owns a copyright for the images of the picture hanging toolkit. The copyright registration number is VA 2-250-655. The copyright's effective date of registration is April 19, 2021.
10. Defendant, JameslyCR, does not have permission from either Aacraft, Inc. or Ms. Hammond to use, manufacture, and sell the Infringing Products that violate Plaintiff's design patent and copyright.

IV. COUNT 1 – DIRECT PATENT INFRINGEMENT

11. Plaintiff reasserts and incorporates herein by reference, each of the allegations in paragraphs 1 through 11 of the Complaint.
12. Attached to the Complaint as Exhibit A, and incorporated herein by reference, is the design patent issued to Shari Hammond, owner and director of Aacraft, Inc., on September 8, 2020. This is a valid patent issued by the US Patent & Trademark Office.
13. Aacraft, Inc. is the rightful owner of the patent at issue in this matter and has always been the rightful owner of the patent at issue in this matter. As the exclusive owner of the patent, Plaintiff enjoys all rights of reproduction, distribution, manufacture, and sale of the patented product.
14. Aacraft, Inc. has not given Defendant permission or authorization to use, modify, manufacture, make, or sell the product that is the subject of the design patent.
15. Nevertheless, Defendant is manufacturing and selling a picture hanging kit, which is more than substantially similar to Plaintiff's picture hanging kit, protected by the design patent, on various websites, including but not limited to Amazon. Defendant's advertising and sale of these Infringing Products are done intentionally to convert Plaintiff's

intellectual property rights and illegally divert income allocable to Plaintiff's product for Defendant's own use. Copies of screenshots showing Defendant selling the Infringing Products on Amazon Attached as Exhibit B, and incorporated herein by reference, are copies of screenshots showing Defendant selling the Infringing Products on Amazon and are reproduced below.

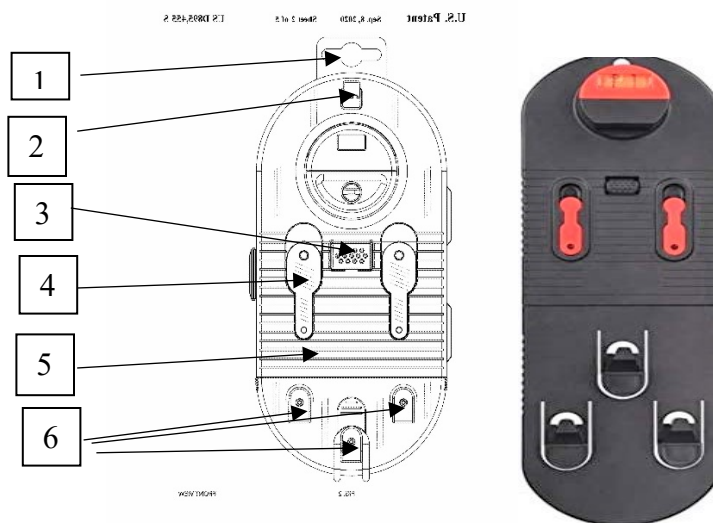
16. The Infringing Products are identical and/or substantially similar to Plaintiff's patented product in violation of U.S. patent law.
17. Upon information and belief, Defendant's acts, infringes, and continues to infringe the claim of D495 patent at least by manufacturing, importing, distributing, selling, and offering for sale, and or using withing the United States at the Defendant's Accused product and acts as alleged herein, are a direct infringement of Plaintiff's patent under 35 U.S.C. § 271(a).
18. Defendant has continued to infringe Plaintiff's patent, causing Plaintiff irreparable harm, and such actions by Defendant have led to actual confusion amongst consumers within this jurisdiction. As a result of Defendant's infringement of the D495 patent, Plaintiff has suffered and will continue to suffer damages. Plaintiff is entitled to recover damages adequate to compensate it for such infringement, but in no event less that a reasonable royalty, as permitted under 35 U.S.C. § 285, as well as all remedies for design patent infringement permitted under 35 U.S.C. § 289.
19. Plaintiff has sustained and will continue to sustain, substantial injuries, loss, and damage to its exclusive rights under the patent laws regarding the patented product as listed in

Exhibit A, and Plaintiff will continue to sustain damages from the loss of value of the exclusive rights thereunder by reason of Defendant's conduct.

20. The above-described conduct by Defendant constitutes willful patent infringement under the patent laws of the U.S. As a result of the above-described conduct by Defendant, Plaintiff has been damaged in an amount to be proven at trial. Plaintiff is entitled to recover damages adequate to compensate it
21. By reason of the patent laws of the U.S., Plaintiff is entitled to recover Defendant's profits to the extent they are not included as part of Plaintiff's damages.
22. Plaintiff is also entitled to recover its reasonable attorney's fees from Defendant to enforce Plaintiff's intellectual property rights.
23. The similarities between the **FIG. 2** from Plaintiff's patented design, shown below on the left and the Defendant's accused product on the right are set out below. These similar elements are ornamental and are not found in the prior art.

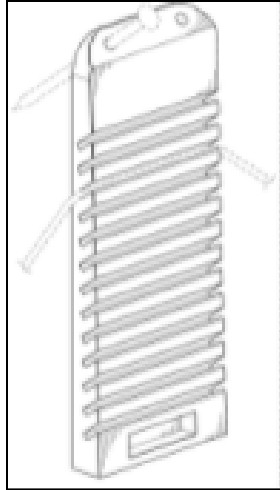

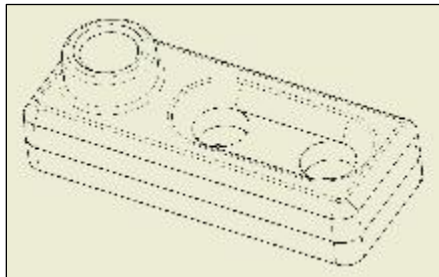

The Defendant's accused product includes at least non-functional ornamental elements **1-6** from the Plaintiff's patented design. The Defendant's product appearance is closer to the Plaintiff's patented design than it is to the prior art. Both the Plaintiff's patented design and the Defendant's product have a similar shaped, positioned, and proportioned hang tag **1**. Both the Plaintiff's patented design and the Defendant's product

have a similar shaped, positioned and proportioned square **2** under the hang tag. Both the Plaintiff's patented design and the Defendant's product have a similar shaped, positioned and proportioned a rectangle **3** positioned between two keys. Both the Plaintiff's patented design and the Defendant's product have a similar shaped, positioned and proportioned have 2 keys **4**. Both the Plaintiff's patented design and the Defendant's product have a similar shaped, positioned and proportioned horizontal stripes **5** and Both the Plaintiff's patented design and the Defendant's product have a similar shaped, positioned and proportioned triangular arrangement of hooks **6**.

As shown below, both the plaintiff's product and the defendant's product are sold on Amazon and look substantially similar. Thus the overall appearance of the patented design and the accused product are substantially similar. A design patent is infringed "[i]f, in the eye of an ordinary observer, giving such attention as a purchaser usually give, tow designs are substantially the same, if the resemblance is such as to deceive such an observer, inducing." him to purchase one supping it to be the other." *Egyptian Goddess*, 543 F.3d at 670. Thus, it is believed the Defendant's product directly infringes the Plaintiff's design patent.

V. COUNT 2 – DIRECT COPYRIGHT INFRINGEMENT

24. Plaintiff reasserts and incorporates herein by reference, each of the allegations in paragraphs 1 through 24 of the Complaint.
25. Attached to the Complaint as Exhibit C, and incorporated herein by reference, is the registered copyright issued to Aacraft, Inc. on July 10, 2020, and the deposited image associated with this registered copyright. The Registration Number is VA-2-211-473. This is a valid copyright issued by the U.S. Copyright Office.

26. Aacraft, Inc. is the rightful owner of the copyright at issue in this matter and has always been the rightful owner of the copyright at issue in this matter. As the exclusive owner of the copyrighted material, Plaintiff enjoys all rights of reproduction and distribution of the copyrighted material.
27. Aacraft, Inc. have given Defendant permission or authorization to use, modify, reproduce, or distribute the product that is the subject of the copyrighted material.
28. Nevertheless, Defendant is advertising a picture hanging kit using pictures that are the same as or substantially similar to Plaintiff's copyrighted material, on various websites, including but not limited to Amazon. (See Exhibit B and above comparison of Plaintiff's and Defendant's product pictures on Amazon). Defendant's use of Plaintiff's copyrighted material in advertising for its Infringing Products is done intentionally to convert Plaintiff's intellectual property rights and illegally divert income allocable to Plaintiff's product for Defendant's own use.
29. The advertised products are identical and/or substantially similar to Plaintiff's copyrighted material in violation of U.S. copyright law.
30. Defendant's acts, as alleged herein, are a direct infringement of Plaintiff's copyright.
31. Defendant has continued to infringe Plaintiff's copyright, causing Plaintiff irreparable harm, and such actions by Defendant have led to actual confusion amongst consumers within this jurisdiction.
32. Plaintiff has sustained and will continue to sustain, substantial injuries, loss and damage to its exclusive rights under the copyright laws regarding the copyrighted material as

listed in Exhibit C, and Plaintiff will continue to sustain damages from the loss of value of the exclusive rights thereunder by reason of Defendant's conduct.

33. The above-described conduct by Defendant constitutes willful copyright infringement under the copyright laws of the U.S. As a result of the above-described conduct by Defendant, Plaintiff has been damaged in an amount to be proven at trial.

34. By reason of the copyright laws of the U.S., Plaintiff is entitled to recover Defendant's profits to the extent they are not included as part of Plaintiff's damages.

35. Plaintiff is also entitled to recover its reasonable attorney's fees from Defendant to enforce Plaintiff's intellectual property rights.

VI. REQUEST FOR A JURY TRIAL

36. Plaintiff respectfully requests a jury trial in this matter.

VII. CONCLUSION AND PRAYER

37. WHEREFORE, PREMISES CONSIDERED, Plaintiff respectfully requests judgment in its favor against Defendant for all causes of action herein, and upon final trial receive:

- a. Adjudge that Defendant has directly infringed, literally or under the doctrine of equivalents, claim 1 of the D495 patent, and that the manufacture, use, sale, offer for sale and /or importation of at least the Accused Product infringes claim 1 of the D495 patent.
- b. An order preliminarily enjoining Defendant, their officers, agents, employees, and those acting in concert or conspiracy with them temporarily during the pendency of this action and permanently thereafter from infringing, contributing to, or participating in the infringement of others of the D495 Patent and copyrighted

material rightfully owned by Plaintiff by manufacturing, selling, copying, duplicating, licensing, displaying, distributing, or otherwise without authorization by Plaintiff;

- c. Award Plaintiff damages to compensate for Defendant's infringement of the D495 patent, but in no event less than a reasonable royalty permitted by 35 USC §284 together with prejudgment interest from the date the infringement began;
- d. That Defendant be required to pay over to the account of Plaintiff the actual damages suffered by Plaintiff as a result of the infringements and any profits of the Defendant earned and attributable to the infringements of Plaintiff's patented product and copyrighted material and to pay such other damages as this Court shall appear just and proper under U.S. patent and copyright laws;
- e. Award Plaintiff the total profit made by Defendant from its infringement of the D495 patent under 35 U.S.C. §289.
- f. Award Plaintiff increased damages under 35 U.S.C. §284;
- g. Declare this to be an exceptional case under 35 U.S.C. §285.
- h. That Defendant be required to pay Plaintiff triple damages for Defendant's patent infringement;
- i. Award of costs under 35 U.S.C. §284 or otherwise provided by law;
- j. Award of attorney's fees pursuant to 35 U.S.C. §285;
- k. Pursuant to 17 U.S.C. § 502,

(1) permanently enjoin Defendant and his agents, servants, employees, and attorneys; and all other persons who are in active concert or participation with

any of the aforementioned from publishing or trafficking the Infringing Work or any other work derivative of Plaintiff's Copyright;

(2) order that Defendant remove all copies of the Infringing Work from any chain of distribution including online and in stores

(3) order that all labels, signs, prints, packages, wrappers, receptacles, photographs, and advertisements in the possession of the Defendant or his agents or co-conspirators, depicting or promoting the Infringing Work, or a colorable imitation thereof, and all plates, molds, matrices, negatives, and other means of making the same, be delivered up to this Court and destroyed;

(4) order Defendant to file with the Court and serve on the Plaintiff within thirty days (30) after the service on the Defendant of the permanent injunction, a report in writing under oath setting forth in detail the manner and form in which Defendant has complied with the injunction.

- l. Award Plaintiff damages, including copyright infringement damages pursuant to 17 U.S.C. § 504(b);
- m. Award Plaintiff Defendants' copyright infringement profits pursuant to 17 U.S.C. § 504(b);
- n. Award Plaintiff copyright infringement statutory damages of \$30,000 for each copyright infringement pursuant to 17 U.S.C. § 504(c)(1);
- o. Award Plaintiff maximum statutory damages for willful copyright infringement of \$150,000 pursuant to 15 U.S.C. § 504(c)(2);
- p. Award Plaintiff its costs and attorneys' fees as part of the costs pursuant

to 17 U.S.C. § 505;

- q. Award of prejudgment interest and post judgment interest in the maximum amount permitted by law; and
- r. For such other and further relief this Court deems just and proper and Plaintiff is entitled to.

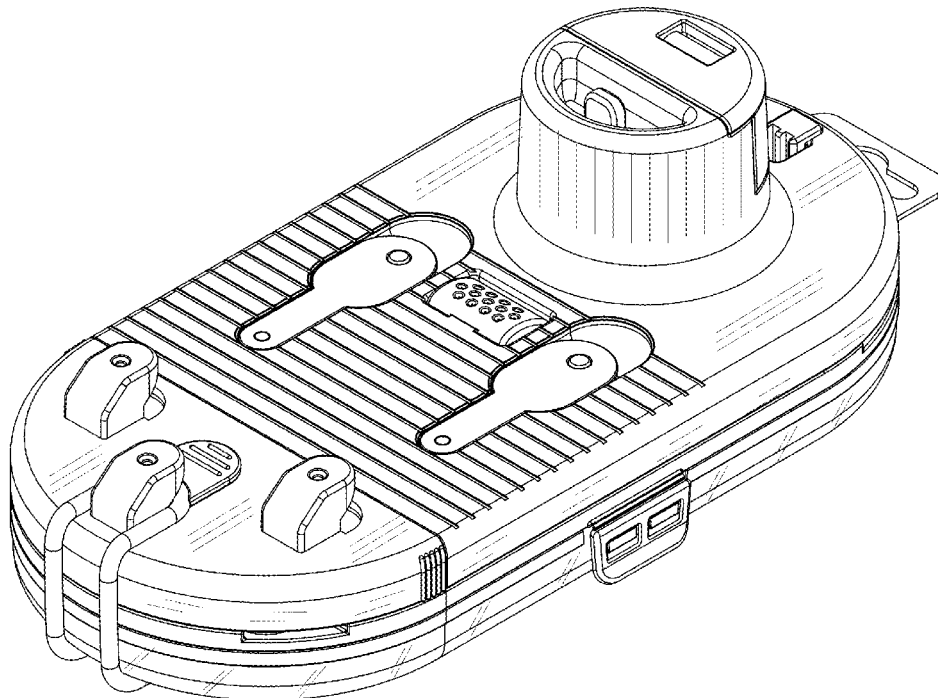

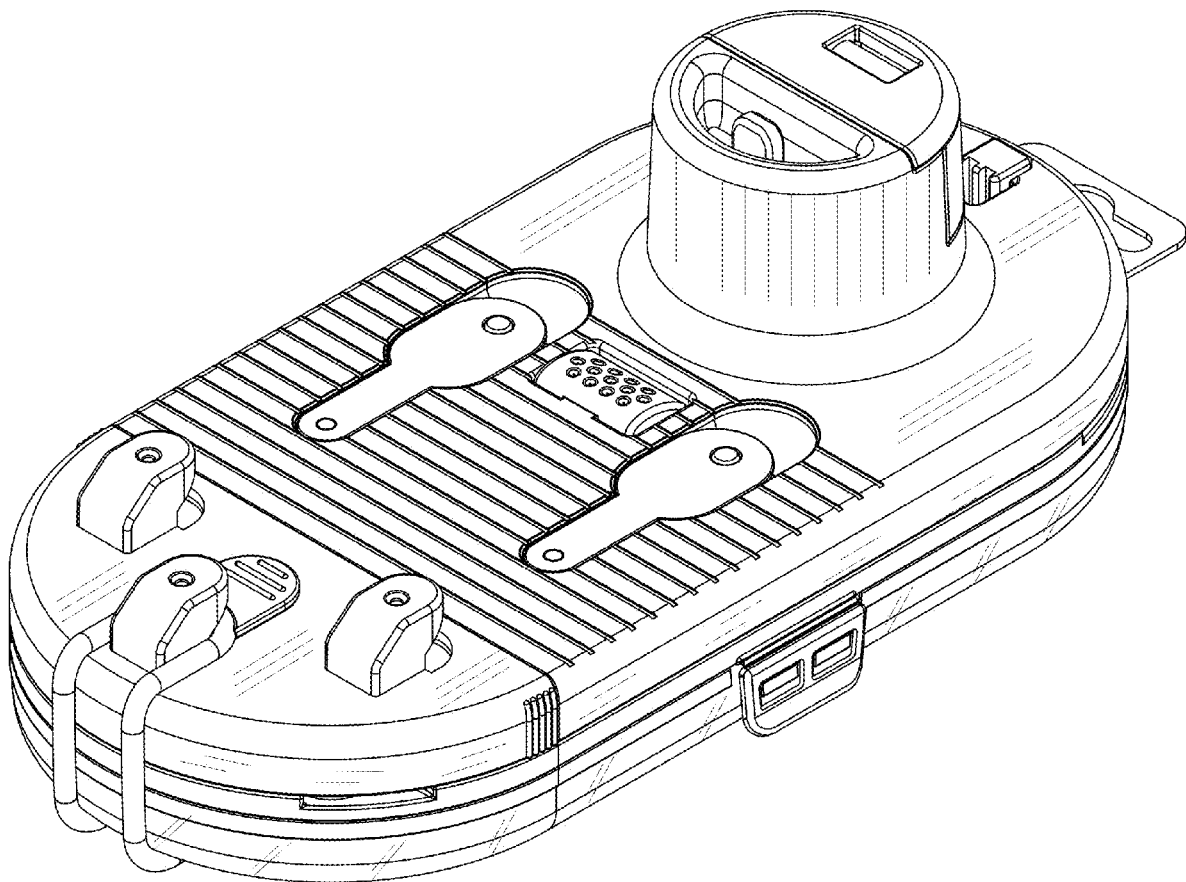

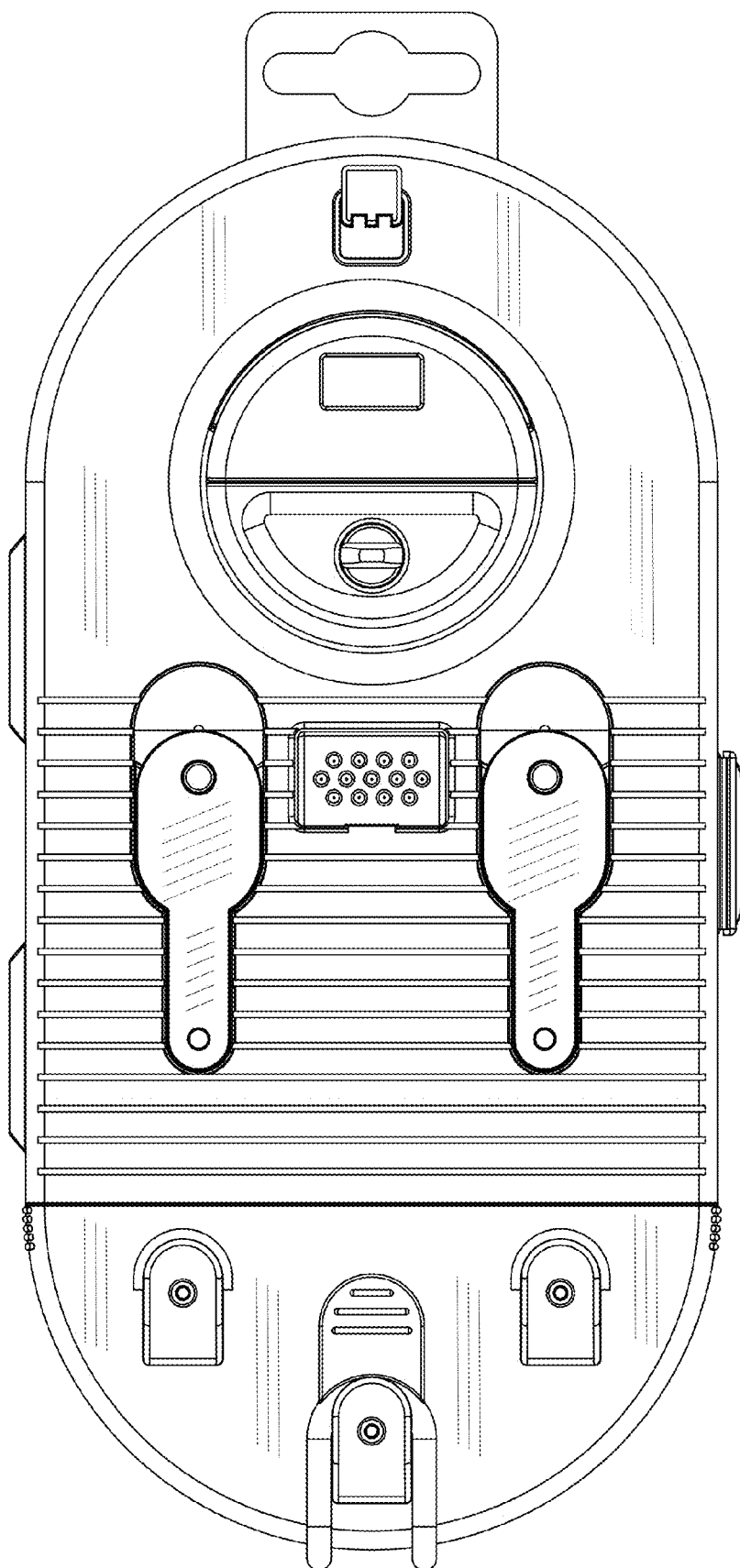

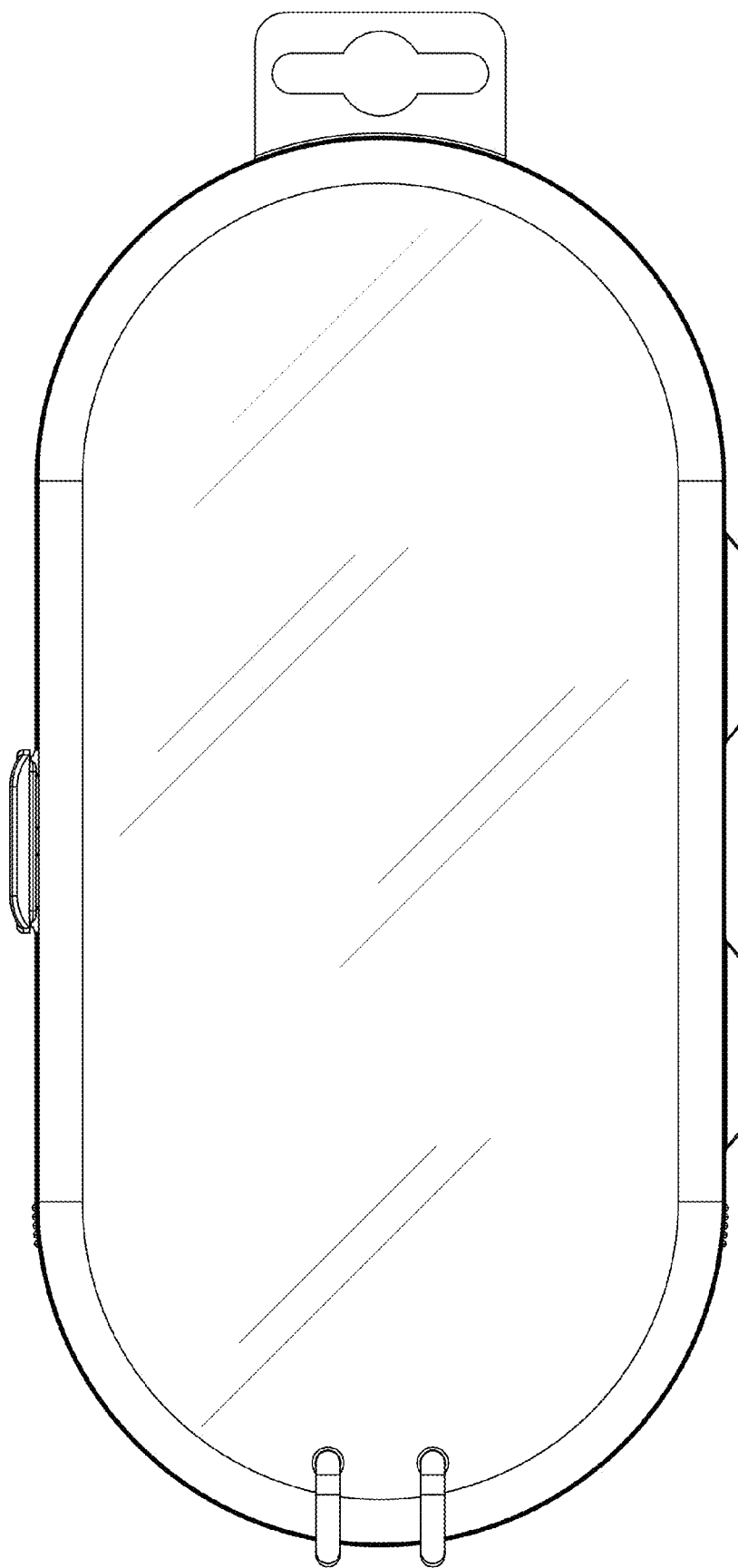

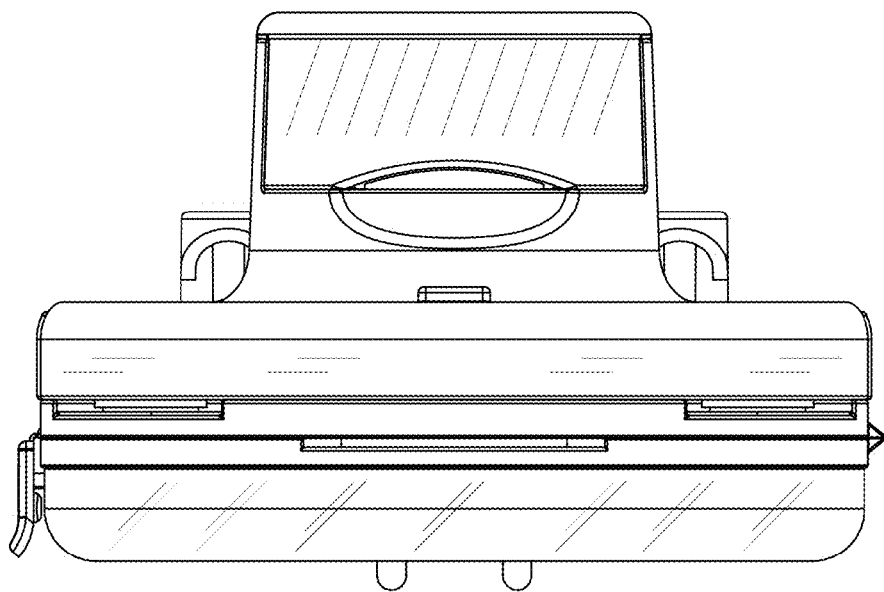

TOP VIEW

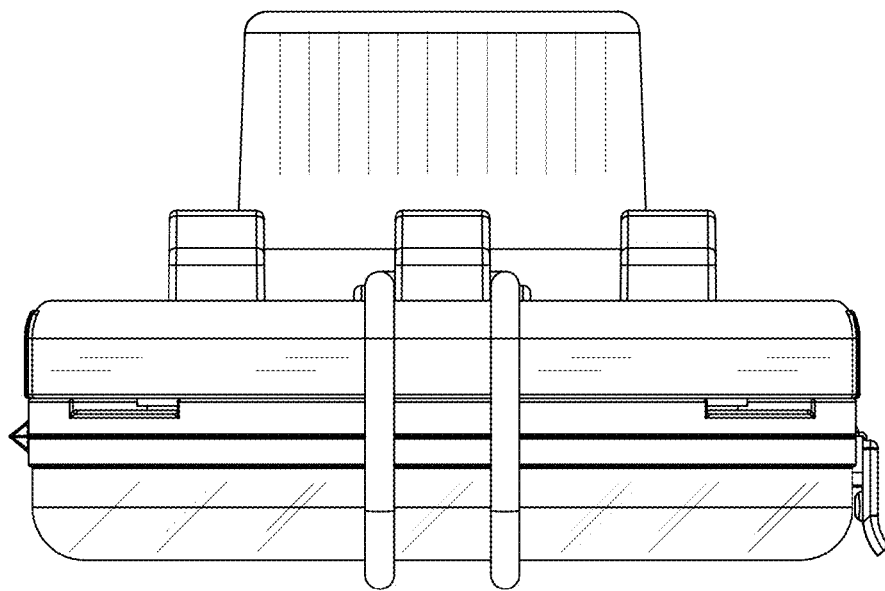

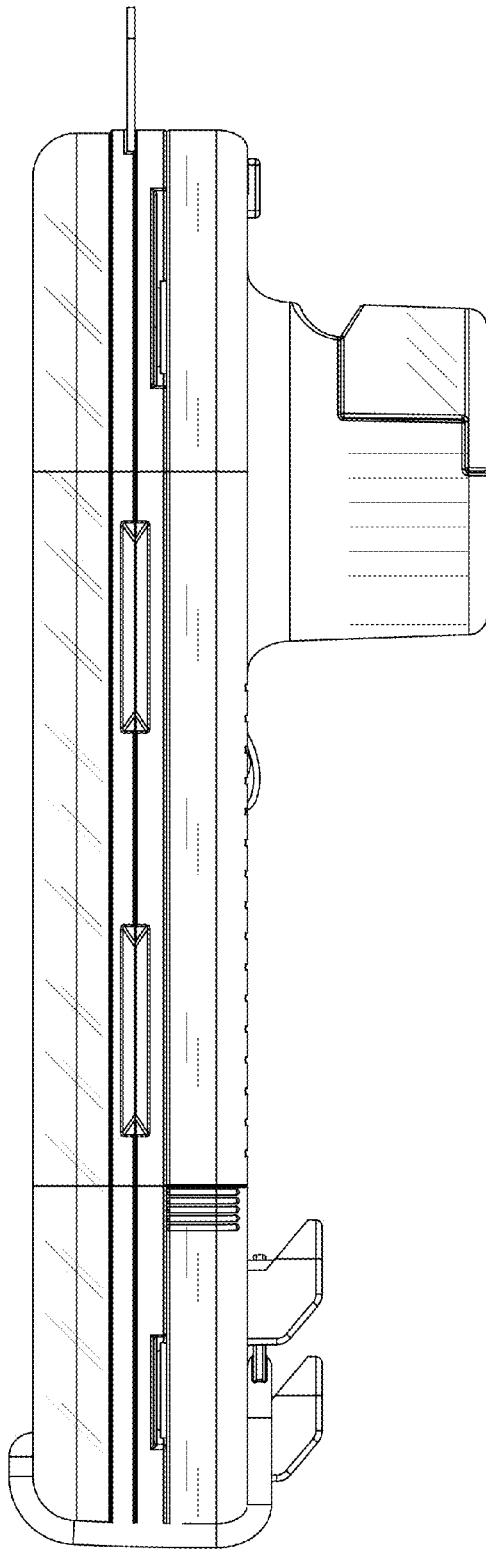


FIG. 6 LEFT-SIDE VIEW

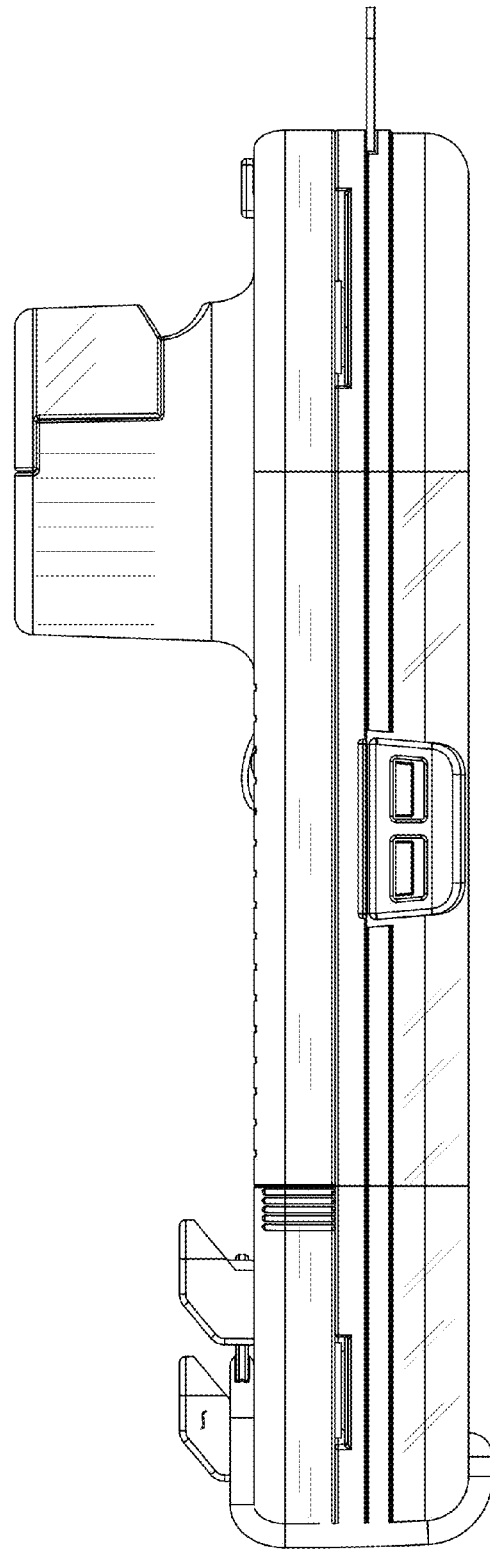


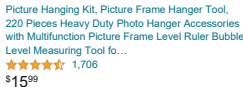
FIG. 7 RIGHT-SIDE VIEW

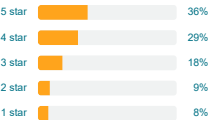
