**NOTICE OF APPEAL**

Plaintiff in the above-named case, Kolcraft Enterprises, Inc. (“Kolcraft”), hereby appeals to the United States Court of Appeals for the Federal Circuit from the portion of the Memorandum Opinion and Order entered by the District Court on September 6, 2019 (Dkt. #473 (“Order”)) and the Final Judgment of September 18, 2019 (Dkt. #476, Judgment in a Civil Case (entering judgment in favor of Kolcraft)) finding that Kolcraft is not entitled to enhanced damages and/or attorneys’ fees after the jury returned a verdict in favor of Kolcraft on all claims and awarded \$3,245,213.10 in damages. Kolcraft does not appeal any other portion of the District Court’s Order and/or Final Judgment.

Contemporaneously with the filing of this Notice, Kolcraft is making payment of \$505.00, representing the \$500.00 docketing fee required by 28 U.S.C. § 1913 and Rule 3(e) of the Federal Rules of Appellate Procedure, and the \$5.00 fee for filing a notice of appeal required by 28 U.S.C. § 1917 and the local rules of this Court.
