DEFENDANT REALTEK SEMICONDUCTOR CORPORATION'S NOTICE OF APPEAL

Pursuant to 28 U.S.C. § 1295(a) and Rules (3)(a)(1) and 4(a)(1)(A) of the Federal Rules of Appellate Procedure, Defendant Realtek Semiconductor Corporation (“Realtek”) hereby gives notice that it appeals to the United States Court of Appeals for the Federal Circuit from (1) the “Sealed Omnibus Order and Memorandum Opinion” issued on September 12, 2022, at Dkt. No. 80, denying Realtek’s motion for sanctions under Federal Rule of Civil Procedure 11 (Dkt. 39), granting in part Realtek’s motion for attorneys’ fees and costs (Dkt. 56), and modifying the voluntary dismissal of the case (Dkt. 54)*; and (2) the sealed “Discovery Order” issued on October 10, 2022, at Dkt. No. 87, denying Realtek’s requests for relief as to redactions, “Outside Attorneys’ Eyes Only” designations, and disclosure of materials to outside counsel.

* Realtek is filing this Notice of Appeal at this time as a protective measure, in so far as Realtek, on October 11, 2022, filed a timely motion for reconsideration of the order denying its request for attorneys’ fees and costs (Dkt. 91).
