Notice is hereby given that Plaintiff Island Intellectual Property LLC (“Island”) appeals to the United States Court of Appeals for the Federal Circuit from all opinions, orders, judgments, decisions, findings, conclusions, or rulings in this action decided adversely to Island in the above-captioned case, including without limitation: (1) this Court’s Report and Recommendation entered on September 28, 2022, recommending that Defendants’ motion for summary judgment (the “Summary Judgment Motion”) to invalidate the claims in dispute, for claiming patent-ineligible subject matter, be granted (Dkt. 184) (the “R&R”), and (2) this Court’s Order entered on November 17, 2022 overruling Island’s objections to the R&R, adopting the R&R, and granting Defendants’ Summary Judgment Motion (Dkt. 193).

To the extent this notice is deemed filed “before the entry of the judgment,” this notice shall be “treated as filed on the date of and after the entry” of judgment. Fed. R. App. P. 4(a)(2).
