## **DEFENDANTS' PROTECTIVE NOTICE OF APPEAL**

Notice is hereby given that Defendants DePuy Synthes Products, Inc. and DePuy Synthes Sales, Inc. ("DePuy") in the above-captioned matter hereby appeal to the United States Court of Appeals for the Federal Circuit from the Court's March 30, 2023 Order on Post-Trial Motions (D.I. 331), which concludes that Plaintiff "has satisfied the *eBay* factors required to obtain a permanent injunction as to infringement of the '180 patent" (*id.* at 7), and grants Plaintiff's motion for a permanent injunction (*id.* at 8).
