Pursuant to Rules 3 and 4 of the Federal Rules of Appellate Procedure, Rule 3 of the United States Court of Appeals for the Federal Circuit, and 28 U.S.C. §§ 1291 & 1292(c)(2), notice is hereby given that Defendants and Counterclaim Plaintiffs Crown Packaging Technology, Inc. and Crown Cork & Seal USA, Inc. (collectively, “Crown”) appeal to the United States Court of Appeals for the Federal Circuit from, to the extent adverse to Crown, the decision issued by this Court on August 3, 2023 (Doc. No. 224), the judgment entered therefrom, and any and all other orders, rulings, findings, and/or conclusions adverse to Crown. The issues on appeal include, but may not be limited to, the Court’s decision sustaining Ball Metal Beverage Container Corp. and Rexam Beverage Can Company’s Renewed Motion for Summary Judgment on Indefiniteness (Doc. No. 196).

The remedy sought on appeal is reversal of the issues decided adversely to Crown, including, but not limited to, the Court’s decision that the asserted claims are invalid for being indefinite. *Mentor Graphics Corp. v. EVE-USA, Inc.*, 851 F.3d 1275, 1294 (Fed. Cir. 2017) (“We reverse the grant of summary judgment of indefiniteness.”).

Provided with this Notice of Appeal is the \$505.00 fee required for docketing and filing the appeal.
