

denying in part Techiya's Motion to Compel Unredacted Exhibits (Dkts. 844, 846, 863); the Court's pre-trial hearing rulings (Dkts. 687, 690, 739, 742, 862, 865, 869, 881, 882, 888, 902); the Court's March 26, 2024 Order overruling Techiya's objections to Magistrate Judge Payne's pre-trial conference rulings regarding the Korean Witness Interview Summaries (Dkt. 894); the Court's evidentiary rulings during the bench trial (Dkts. 891, 898–901, 903); and the Court's order granting Samsung's motion to redact the bench trial transcript (Dkt. 932).

All parties' claims are now adjudicated. Because this civil action involved the final decision of a District Court in a civil action arising under an Act of Congress relating to patents, the United States Court of Appeals for the Federal Circuit has exclusive jurisdiction over this appeal pursuant to 28 U.S.C. § 1295(a).
