NOTICE OF APPEAL

Notice is hereby given that Plaintiff VB Assets, LLC (“VB Assets”) appeals to the United States Court of Appeals for the Federal Circuit from the Court’s Order granting-in-part and denying-in-part Amazon’s Motion for Judgment as a Matter of Law, and granting-in-part and denying-in-part VB Assets’s Motion for an Ongoing Royalty, Pre-Judgment Interest, Post-Judgment Interest, and Enhanced Damages, dated September 30, 2024 (Dkt. 326), and any other pertinent interlocutory decisions, rulings, findings, or orders, or rulings, findings, or orders incorporated therein, including but not limited to the decision granting Amazon’s Motion for Judgment as a Matter of Law on infringement of U.S. Patent No. 9,626,703 (“the ’703 patent”). This Notice of Appeal is filed within 30 days of entry of the order disposing of the last remaining motion for judgment under Rule 50(b) and is therefore timely under Federal Rule of Appellate Procedure 4(a)(1)(A) and 4(a)(4)(A)(i).
