COMPLAINT AND DEMAND FOR JURY TRIAL

NOW COMES Plaintiff, David H. Sitrick, by his attorneys and for his Complaint against Defendant, Take-Two Interactive Software, Inc., alleges the following:

- 1. This is an action for patent infringement arising under the patent laws of the United States (Title 35, United States Code) as appears more fully hereinafter. This Court has jurisdiction under Title 28, United States Code, Section 1338(a); and venue lies in this District under the provisions of Title 28, United States Code, Section 1400(b).
- Plaintiff, David H. Sitrick, is a resident of the state of Illinois and of this
 District.
- 3. On February 25, 1986, United States Patent No. 4,572,509 (hereinafter "the '509 patent") was duly and legally issued to Plaintiff for a "Video Game Network" invented by Plaintiff, and since that date, Plaintiff has been and still is the owner of the '509 patent, a copy of which is attached to this Complaint as Exhibit A.

- 4. On information and belief, Defendant, Take-Two Interactive Softwre, Inc., is doing business in this District, has a principal place of business at 622 Broadway, New York, New York 10012, and is a publisher of game software.
- 5. Defendant has for a long time past directly, contributorily, and/or by inducement infringed the '509 patent in this district and elsewhere in the United States by making, selling, offering for sale, and/or using electronic games and software therefor.
 - 6. Plaintiff has given written notice to Defendant.
 - Acts of infringement by Defendant have been willful and deliberate.
 WHEREFOR, Plaintiff prays that this Court:
- A. Adjudge United States Patent No. 4,572,509 to be infringed by Defendant and not invalid;
- B. Order Defendant to account to Plaintiff for damages sustained by Plaintiff as a result of Defendant's infringement of United States Patent No. 4,572,509, with interest, said damages so found then to be increased three-fold pursuant to 35 U.S.C. § 285 upon the Court's finding that the present case is exceptional;
- C. Award Plaintiff his costs, expenses, and reasonable attorney fees for bringing and prosecuting this action; and
- D. Award Plaintiff such other and further relief as the Court may deem just and proper.
