Parties and Jurisdiction

- Defendant, Healtheon/WebMD Corporation ("WebMD") is a corporation organized under the laws of the State of Delaware, having a principal place of business at 669 River Drive, Center 2, Elmwood Park, New Jersey 07407.

COUNT I PATENT INFRINGEMENT

- 6. NPM incorporates the allegations of the foregoing Paragraphs 1-5 as though fully set forth herein.
- 7. On December 3, 1991, United States Patent No. 5,070,452, entitled "COMPUTERIZED MEDICAL INSURANCE SYSTEM INCLUDING MEANS TO AUTOMATICALLY UPDATE MEMBER ELIGIBILITY FILES AT PRE-ESTABLISHED INTERVALS" ("the '452 patent"), was duly and legally issued by the United States Patent and Trademark Office to NGS American, Inc. A copy of the '452 patent is attached hereto as Exhibit A.
- 8. NPM is the current assignee of all right, title and interest in the '452 patent, including the right to bring and maintain this action with respect to the '452 patent.
- 9. Envoy and WebMD have made, used, offered for sale, and sold in the United States services infringing the '452 patent and has otherwise committed acts prohibited by 35 U.S.C. §271.
 - 10. Upon information and belief, Envoy continues to infringe the '452 patent.
 - 11. Envoy and Web MD's infringement is willful and intentional.
- 12. As a result of Envoy and WebMD's activities and infringement, NPM has suffered and will continue to suffer substantial damages.
- 13. Envoy and WebMD's infringement of the '452 patent will continue unless and until enjoined by this Court.

- D. finds this to be an exceptional case pursuant to 35 U.S.C. §285 and awards NPM its attorneys' fees and costs incurred in this matter.
- E. permanently enjoin Envoy and WebMD and their subsidiaries, agents, officers, and employees, and all others acting in concert with it, from further infringement of the '452 patent under penalty of contempt; and
- F. awards NPM such other and further equitable relief as the Court may deem necessary and proper to correct the injury to NPM and to the public interest caused by Envoy and WebMD's unlawful conduct.

Plaintiff requests a jury trial on all issues triable by a jury.
