RIM, on information and belief, manufactures, uses, and sells products that infringe at least Claims 14-18 and 20 of the '009 patent, including for example and without limitation RIM's Blackberry 7100t cellular telephone device, as well as any other cellular telephones or devices acting or capable of acting in the manner described and claimed in the '009 patent.

Palm, on information and belief, manufactures, uses, and sells products that infringe at least Claims 14-18 and 20 of the '009 patent, including for example and without limitation Palm's Treo 650 cellular telephone device, as well as any other cellular telephones or devices acting or capable of acting in the manner described and claimed in the '009 patent.
- 32. The infringement of the '009 patent alleged above has injured the Plaintiff and thus, it is entitled to recover damages adequate to compensate for Samsung, Motorola, Nokia, Sony, Siemens, LG, RIM, and Palm's infringement, which in no event can be less than a reasonable royalty.

DEMAND FOR JURY TRIAL

33. Plaintiff hereby demands a jury trial on all claims and issues.

PRAYER FOR RELIEF

Wherefore, Plaintiff prays for entry of judgment:

- A. that Defendants, Samsung, Motorola, Nokia, Sony, Siemens, LG, RIM, and Palm, have infringed one or more claims of the '009 patent;
- B. that Defendants, Samsung, Motorola, Nokia, Sony, Siemens, LG, RIM, and Palm, account for and pay to Plaintiff all damages caused by the infringement of the '009 patent, which by statute can be no less than a reasonable royalty;
- C. that Plaintiff be granted pre-judgment and post-judgment interest on the damages caused to them by reason of Defendants, Samsung, Motorola, Nokia, Sony, Siemens, LG, RIM, and Palm's infringement of the '009 patent;
 - D. that Plaintiff be granted its attorneys' fees in this action;
 - E. that costs be awarded to Plaintiff;
- F. that Plaintiff be granted such other and further relief as the Court may deem just and proper under the current circumstances.
