(collectively, “Watson”) hereby appeal to the United States Court of Appeals for the Federal Circuit from the Judgment entered in Civil Action No. 09-724-SLR in favor of Plaintiffs, entered on March 24, 2011 (D.I. 196), and from all underlying decisions, orders, opinions, and rulings decided adversely to Watson in the above-captioned case, including, but not limited to the Court’s Opinion, entered on March 24, 2011 (D.I. 194), finding U.S. Patent No. 6,264,981 valid and infringed; the order entered on March 24, 2011 (D.I. 195) denying in part and denying in part as moot Watson’s motion to strike expert testimony, and denying Watson’s motion to vacate the Court’s October 28, 2010 order staying launch of Watson’s generic drug product; and all other orders, rulings, and findings decided adversely to Watson made prior to and during trial.
