COMPLAINT

Plaintiff Leo A. Metzger (hereinafter "Metzger") for his Complaint against defendants CNH America, L.L.C. f/k/a Case, L.L.C. and New Holland North America, Inc., (hereinafter collectively "CNH") states as follows:

- This is an action for patent infringement arising under the patent laws of the
 United States of America, Title 35 United States Code.
 - 2. Leo A. Metzger is an individual residing in Circleville, Ohio, 43113.
- 3. Upon information and belief, defendant CNH America, L.L.C. is a limited liability corporation organized and existing under the laws of the State of Delaware, having offices in Racine, Wisconsin 53404. CNH America, L.L.C was formerly known as Case, L.L.C.
- 4. Upon information and belief, defendant New Holland North America, Inc. is a corporation organized and existing under the laws of the State of Delaware having offices in New Holland, Pennsylvania.

- 5. This Court has jurisdiction of this matter under the provisions of 28 U.S.C. \$1338(a). Venue is proper under 28 U.S.C. \$1400(b).
- 6. On February 25, 2003, United States Letters Patent 6,523,333 entitled "SENSOR ARM FOR COMBINE HEADER" (the "'333" patent) was duly and legally issued to Leo A Metzger. Mr. Metzger continues to own the 333 patent.
- 7. Defendants, CNH, have been and continue willfully to infringe the 333 patent by making, using and/or selling agricultural combines and cornheads for combines, including two such combines sold by Case, L.L.C. under Models 8010 and 2388, and will continue to do so unless enjoined by this Court.

WHEREFORE, plaintiff respectfully requests that the Court enter judgment for plaintiff and enter an Order providing the following:

- a. That defendants, their subsidiaries, affiliates, officers, agents, employees and all other persons in active concert or participation with defendants be enjoined preliminary and permanently from any further infringement of the 333 Patent;
 - b. That plaintiff be awarded damages for all infringing activities;
- c. That the infringement be found willful and award of damages be trebled;
- d. That this matter be declared exceptional, and that plaintiff be awarded interest and costs of this action including reasonable attorneys' fees;
- e. That plaintiff be awarded such other and further relief as may be just and proper.

Trial by jury is demanded by plaintiff under Rule 38(b) of the Federal Rules of Civil

Procedure.
