#### COMPLAINT FOR PATENT INFRINGEMENT

MAGISTRATE JUDGE ROSE

Plaintiff, Solaia Technology LLC ("Solaia"), complains of Defendant, Jefferson Smurfit, Corporation ("Jefferson Smurfit"), as follows:

- 1. This is a claim for patent infringement arising under the patent laws of the United States, Title 35 of the United States Code. This Court has exclusive jurisdiction over the subject matter under 28 U.S.C. § 1338(a).
- 2. Solaia is an Illinois limited liability company with its principal place of business in Chicago, Illinois. Solaia owns all right, title and interest in and has standing to sue for infringement of United States Patent No. 5,038,318 ("the '318 Patent"), entitled "Device For Communicating Real Time Data Between A Programmable Logic Controller And A Program Operating In A Central Controller."
- 3. Jefferson Smurfit is a Delaware corporation with operating facilities located in this judicial district, including those located in Carol Stream, Illinois, and elsewhere.
  - 4. Venue is proper in this district under 28 U.S.C. §§ 1391 and 1400(b).

- 5. Defendant Jefferson Smurfit has infringed the patent in suit through, among other activities, the use of the patented system along with its processes for industrial automation.
- 6. Jefferson Smurfit's infringement has injured Solaia, and Solaia is entitled to recover damages adequate to compensate it for such infringement, but in no event less than a reasonable royalty.
- 7. Jefferson Smurfit's infringement has been willful and deliberate and has injured and will continue to injure Solaia, unless and until this Court enters an injunction prohibiting further infringement and, specifically, enjoining further use of the patented system and corresponding processes and the further manufacture of products made through the use of the inventions claimed in the '318 patent.

WHEREFORE, Plaintiff, Solaia, asks this Court to enter judgment against Defendant, Jefferson Smurfit, and against its subsidiaries, affiliates, agents, servants, employees and all persons in active concert or participation with them, granting the following relief:

- A. An award of damages adequate to compensate Solaia for the infringement that has occurred, together with prejudgment interest from the date infringement of the patents in suit began;
- B. Increased damages as permitted under 35 U.S.C. § 284;
- C. A finding that this case is exceptional and an award to Solaia of its attorneys' fees and costs as provided by 35 U.S.C. § 285;
- D. A permanent injunction prohibiting further infringement, inducement and contributory infringement of the patents in suit; and,
- E. Such other and further relief as this Court or a jury may deem proper and just.

### **JURY DEMAND**

Solaia demands a trial by jury on all issues so triable.
