1 **COMPLAINT FOR PATENT INFRINGEMENT**

2 Plaintiff Ameranth, Inc., for its Complaint against defendants Naama Networks, Inc.  
3 d/b/a Ordriin d/b/a ordri.in and Ordri.in, Inc. (collectively referred to herein as “Ordriin” or  
4 “Defendant”), avers as follows:

5 **PARTIES**

6 1. Plaintiff Ameranth, Inc. (“Ameranth”) is a Delaware corporation having a principal  
7 place of business at 5820 Oberlin Drive, Suite 202, San Diego, California 92121. Ameranth  
8 develops, manufactures and sells, *inter alia*, hospitality industry, entertainment, restaurant and  
9 food service information technology solutions under the trademarks 21<sup>st</sup> Century  
10 Communications™, and 21st Century Restaurant™, among others, comprising the  
11 synchronization and integration of hospitality information and hospitality software applications  
12 between fixed, wireless and/or internet applications, including but not limited to computer  
13 servers, web servers, databases, affinity/social networking systems, desktop computers,  
14 laptops, “smart” phones and other wireless handheld computing devices.

15 2. Defendant Naama Networks, Inc. d/b/a Ordriin d/b/a ordri.in is, on information and  
16 belief, a Delaware corporation having a principal place of business and headquarters in New  
17 York, New York. Defendant Ordri.in, Inc. is, on information and belief, a Delaware  
18 corporation having a principal place of business and headquarters in New York, New York.  
19 These two entities are collectively referred to herein as “Ordriin” or “Defendant”. On  
20 information and belief, Ordriin makes, uses, sells and/or offers for sale, restaurant, foodservice,  
21 point-of-sale and property management and other hospitality information technology products,  
22 software, components and/or systems within this Judicial District, including the Ordriin  
23 Products as defined herein.

24 **JURISDICTION AND VENUE**

25 3. This is an action for patent infringement arising under the Patent Laws of the United  
26 States, 35 U.S.C. §§ 271, 281-285.

27 4. This Court has subject matter jurisdiction pursuant to 28 U.S.C. §§ 1331 and  
28 1338(a).



1 computer servers, web servers, databases, affinity/social networking systems, desktop  
2 computers, laptops, “smart” phones and other wireless handheld computing devices.

3 9. Ameranth began development of the inventions leading to the patent-in-suit and the  
4 other patents in this patent family in the late Summer of 1998, at a time when the then-  
5 available wireless and internet hospitality offerings were extremely limited in functionality,  
6 were not synchronized and did not provide an integrated system-wide solution to the pervasive  
7 ordering, reservations, affinity program and information management needs of the hospitality  
8 industry. Ameranth uniquely recognized the actual problems that needed to be resolved in  
9 order to meet those needs, and thereafter conceived and developed its breakthrough inventions  
10 and products to provide systemic and comprehensive solutions directed to optimally meeting  
11 these industry needs. Ameranth has expended considerable effort and resources in inventing,  
12 developing and marketing its inventions and protecting its rights therein.

13 10. Ameranth’s pioneering inventions have been widely adopted and are thus now  
14 essential to the modern wireless hospitality enterprise of the 21st Century. Ameranth’s  
15 solutions have been adopted, licensed and/or deployed by numerous entities across the  
16 hospitality industry.

17 11. The adoption of Ameranth’s technology by industry leaders and the wide acclaim  
18 received by Ameranth for its technological innovations are just some of the many  
19 confirmations of the breakthrough aspects of Ameranth’s inventions. Ameranth has received  
20 twelve different technology awards (three with “end customer” partners) and has been widely  
21 recognized as a hospitality wireless/internet technology leader by almost all major national and  
22 hospitality print publications, *e.g.*, The Wall Street Journal, New York Times, USA Today and  
23 many others. Ameranth was personally nominated by Bill Gates, the Founder of Microsoft, for  
24 the prestigious Computerworld Honors Award that Ameranth received in 2001 for its  
25 breakthrough synchronized reservations/ticketing system with the Improv Comedy Theatres.  
26 In his nomination, Mr. Gates described Ameranth as “one of the leading pioneers of  
27 information technology for the betterment of mankind.” This prestigious award was based on  
28 Ameranth’s innovative synchronization of wireless/web/fixed hospitality software technology.

1 Subsequently, the United States Patent and Trademark Office granted Ameranth a number of  
2 currently-issued patents, two of which are the basis for this lawsuit. Ameranth has issued press  
3 releases announcing these patent grants on business wires, on its web sites and at numerous  
4 trade shows since the first of the presently-asserted patents issued in 2002. A number of  
5 companies have licensed patents and technology from Ameranth, recognizing and confirming  
6 the value of Ameranth's innovations.

7 **RELATED CASES PREVIOUSLY FILED**

8 12. The Ameranth patents asserted herein, U.S. Patent No. 6,384,850 (the "'850 patent"),  
9 U.S. Patent No. 6,871,325 (the "'325 patent"), and U.S. Patent No. 8,146,077 (the "'077  
10 patent"), are all patents in Ameranth's "Information Management and Synchronous  
11 Communications" patent family.

12 13. Ameranth is also currently asserting claims of these same patents in separate  
13 lawsuits, against other defendants, that are already pending in this Court. The first-filed  
14 lawsuit asserts claims of the '850 and '325 patents and is entitled *Ameranth v. Pizza Hut, Inc.*  
15 *et al.*, Case No. 3:11-cv-01810-JLS-NLS. Lawsuits subsequently filed by Ameranth in this  
16 Court, asserting claims of the '077 patent, include Case Nos. 3:12-cv-00729-JLS-NLS; 3:12-  
17 cv-00731-JLS-NLS; 3:12-cv-00732-JLS-NLS; 3:12-cv-00733-JLS-NLS; 3:12-cv-00737-JLS-  
18 NLS; 3:12-cv-00738-JLS-NLS; 3:12-cv-00739-JLS-NLS; and 3:12-cv-00742-JLS-NLS.  
19 Another lawsuit subsequently filed by Ameranth in this Court, asserting claims of the '850,  
20 '325, and '077 patents, is Case No. 3:12-cv-00858-JLS-NLS.

21 **COUNT I**

22 **Patent Infringement (U.S. Pat. No. 6,384,850)**

23 **(35 U.S.C. § 271)**

24 14. Plaintiff reiterates and incorporates the allegations set forth in paragraphs 1-13 above  
25 as if fully set forth herein.

26 15. On May 7, 2002, United States Patent No. 6,384,850 entitled "Information  
27 Management and Synchronous Communications System with Menu Generation" ("the '850  
28

1 patent”) (a true and copy of which is attached hereto as **Exhibit A**) was duly and legally issued  
2 by the United States Patent & Trademark Office.

3 16. Plaintiff Ameranth is the lawful owner by assignment of all right, title and interest in  
4 and to the ‘850 patent.

5 17. On information and belief, defendant Ordriin has indirectly infringed and continues to  
6 indirectly infringe one or more valid and enforceable claims of the ‘850 patent, in violation of  
7 35 U.S.C. § 271(b), by actively, knowingly, and intentionally inducing direct infringement by  
8 other persons, by making, using, offering for sale or license and/or selling or licensing  
9 infringing systems, products, and/or services in the United States without authority or license  
10 from Ameranth, including but not limited to the Ordriin products/services, which include, inter  
11 alia, application program interfaces (APIs), apps for smartphones and other computing devices,  
12 apps for Facebook and/or other social networks and Internet sites, and/or other software and/or  
13 hardware to enable clients’ online/mobile ordering systems, integration with e-mail and affinity  
14 program and social media applications such as Facebook, Twitter, Groupon, and YouTube,  
15 and/or other third-party web-based applications, and other hospitality aspects (“Ordriin  
16 Products”).

17 18. On information and belief, systems including one or more of the Ordriin Products, as  
18 deployed and/or used at or from one or more locations by Ordriin, its agents, distributors,  
19 partners, affiliates, licensees, and/or their customers, infringe one or more valid and  
20 enforceable claims of the ‘850 patent, by, *inter alia*, doing at least one of the following: (a)  
21 Generating and transmitting menus in a system including a central processing unit, a data  
22 storage device, a computer operating system containing a graphical user interface, one or more  
23 displayable main menus, modifier menus, and sub-modifier menus, and application software  
24 for generating a second menu and transmitting it to a wireless handheld computing device or a  
25 Web page; and/or (b) Enabling ordering and other hospitality functions via iPhone, Android,  
26 and other internet-enabled wireless handheld computing devices as well as via Web pages,  
27 storing hospitality information and data on at least one central database, on at least one wireless  
28 handheld computing device, and on at least one Web server and Web page, and synchronizing

1 applications and data, including but not limited to applications and data relating to ordering,  
2 between at least one central database, wireless handheld computing devices, and at least one  
3 Web server and Web page; utilizing an interface that provides a single point of entry that  
4 allows the synchronization of at least one wireless handheld computing device and at least one  
5 Web page with at least one central database; allowing information to be entered via Web pages,  
6 transmitted over the internet, and automatically communicated to at least one central database  
7 and to wireless handheld computing devices; allowing information to be entered via wireless  
8 handheld computing devices, transmitted over the internet, and automatically communicated to  
9 at least one central database and to Web pages.

10 19. On information and belief, customers of Ordriin, including consumers and restaurant  
11 operators, use the Ordriin Products. Ordriin provides instruction and direction regarding the use  
12 of the Ordriin Products, and advertises, promotes, and encourages the use of the Ordriin  
13 Products.

14 20. Ordriin has long had knowledge of the '850 patent, and knew or should have known  
15 that its continued offering and deployment of the Ordriin Products, and its continued support of  
16 consumers, restaurant operators, and other users of the Ordriin Products, would induce direct  
17 infringement by those users. Additionally, Ordriin intended that its actions would induce direct  
18 infringement by those users.

19 21. On information and belief, Defendant has indirectly infringed and continues to  
20 indirectly infringe one or more valid and enforceable claims of the '850 patent, in violation of  
21 35 U.S.C. § 271(c).

22 22. By distributing, selling, offering, offering to sell or license and/or selling or licensing  
23 the Ordriin Products, Ordriin provides non-staple articles of commerce to others for use in  
24 infringing systems, products, and/or services. Additionally, Ordriin provides instruction and  
25 direction regarding the use of the Ordriin Products, and advertises, promotes, and encourages  
26 the use of the Ordriin Products. Users of systems including one or more of the Ordriin Products  
27 directly infringe one or more valid and enforceable claims of the '850 patent for the reasons set  
28 forth hereinabove.

1 23. On information and belief, Ordriin has had knowledge of the ‘850 patent, including  
2 knowledge that the Ordriin Products, which are non-staple articles of commerce, have been  
3 used as a material part of the claimed invention of the ‘850 patent, and that there are no  
4 substantial non-infringing uses for the Ordriin Products.

5 24. On information and belief, the aforesaid infringing activities of defendant Ordriin  
6 have been done with knowledge and willful disregard of Ameranth’s patent rights, making this  
7 an exceptional case within the meaning of 35 U.S.C. § 285.

8 25. The aforesaid infringing activity of defendant Ordriin has directly and proximately  
9 caused damage to plaintiff Ameranth, including loss of profits from sales it would have made  
10 but for the infringements. Unless enjoined, the aforesaid infringing activity will continue and  
11 cause irreparable injury to Ameranth for which there is no adequate remedy at law.

12 **COUNT II**

13 **Patent Infringement (U.S. Pat. No. 6,871,325)**

14 **(35 U.S.C. § 271)**

15 26. Plaintiff reiterates and reincorporates the allegations set forth in paragraphs 1-28  
16 above as if fully set forth herein.

17 27. On March 22, 2005, United States Patent No. 6,871,325 entitled “Information  
18 Management and Synchronous Communications System with Menu Generation” (“the ‘325  
19 patent”) (a true and correct copy of which is attached hereto as **Exhibit B**) was duly and legally  
20 issued by the United States Patent & Trademark Office.

21 28. Plaintiff Ameranth is the lawful owner by assignment of all right, title and interest in  
22 and to the ‘325 patent.

23 29. On information and belief, defendant Ordriin has indirectly infringed and continues to  
24 indirectly infringe one or more valid and enforceable claims of the ‘325 patent, in violation of  
25 35 U.S.C. § 271(b), by actively, knowingly, and intentionally inducing direct infringement by  
26 other persons, by making, using, offering for sale or license and/or selling or licensing  
27 infringing systems, products, and/or services in the United States without authority or license  
28 from Ameranth, including but not limited to the Ordriin Products.



1           30. On information and belief, systems including one or more of the Ordriin Products, as  
2 deployed and/or used at or from one or more locations by Ordriin, its agents, distributors,  
3 partners, affiliates, licensees, and/or their customers, infringe one or more valid and  
4 enforceable claims of the '325 patent, by, *inter alia*, doing at least one of the following: (a)  
5 Generating and transmitting menus in a system including a central processing unit, a data  
6 storage device, a computer operating system containing a graphical user interface, one or more  
7 displayable main menus, modifier menus, and sub-modifier menus, and application software  
8 for generating a second menu and transmitting it to a wireless handheld computing device or a  
9 Web page; and/or (b) Enabling ordering and other hospitality functions via iPhone, Android,  
10 and other internet-enabled wireless handheld computing devices as well as via Web pages,  
11 storing hospitality information and data on at least one central database, on at least one wireless  
12 handheld computing device, and on at least one Web server and Web page, and synchronizing  
13 applications and data, including but not limited to applications and data relating to orders,  
14 between at least one central database, wireless handheld computing devices, and at least one

18 operators, use the Ordriin Products in a manner that infringes upon one or more valid and  
19 enforceable claims of the '325 patent. Ordriin provides instruction and direction regarding the  
20 use of the Ordriin Products and advertises, promotes, and encourages the use of the Ordriin  
21 Products.

22           32. On information and belief, Defendant actively induces others to infringe the '325  
23 patent in violation of 35 U.S.C. §271(b) by knowingly encouraging, aiding and abetting  
24 customers of Ordriin, including consumers and restaurant operators, to use the infringing Ordriin  
25 Products in the United States without authority or license from Ameranth.

26           33. On information and belief, Defendant contributorily infringes and continues to  
27 contributorily infringe one or more valid and enforceable claims of the '325 patent, in violation  
28 of 35 U.S.C. § 271(c) by offering to sell and/or selling components of systems on which claims

1 of the '325 patent read, constituting a material part of the invention, knowing that the  
2 components were especially adapted for use in systems which infringe claims of the '325  
3 patent.

4 34. By distributing, selling, offering, offering to sell or license and/or selling or licensing  
5 the Ordriin Products, Defendant provides non-staple articles of commerce to others for use in  
6 infringing systems, products, and/or services. Additionally, Ordriin provides instruction and  
7 direction regarding the use of the Ordriin Products and advertises, promotes, and encourages the  
8 use of the Ordriin Products. Users of the Ordriin Products directly infringe one or more valid  
9 and enforceable claims of the '325 patent, for the reasons set forth hereinabove.

10 35. Ordriin has had knowledge of the '325 patent, including knowledge that the Ordriin  
11 Products, which are non-staple articles of commerce, have been used as a material part of the  
12 claimed invention of the '325 patent, and that there are no substantial non-infringing uses for  
13 the Ordriin Products.

14 36. On information and belief, the aforesaid infringing activities of defendant Ordriin  
15 have been done with knowledge and willful disregard of Ameranth's patent rights, making this  
16 an exceptional case within the meaning of 35 U.S.C. § 285.

17 37. The aforesaid infringing activity of defendant Ordriin has directly and proximately  
18 caused damage to plaintiff Ameranth, including loss of profits from sales it would have made  
19 but for the infringements. Unless enjoined, the aforesaid infringing activity will continue and  
20 cause irreparable injury to Ameranth for which there is no adequate remedy at law.

21 **COUNT III**

23 **(35 U.S.C. § 271)**

24 38. Plaintiff reiterates and incorporates the allegations set forth in paragraphs 1-42 above  
25 as if fully set forth herein.

26 39. On March 27, 2012, United States Patent No. 8,146,077 entitled "Information  
27 Management and Synchronous Communications System with Menu Generation, and  
28 Handwriting and Voice Modification of Orders" (a true copy of which is attached hereto as

1 **Exhibit C** and incorporated herein by reference) was duly and legally issued by the United  
2 States Patent & Trademark Office.

3 40. Plaintiff Ameranth is the lawful owner by assignment of all right, title and interest in  
4 and to the '077 patent.

5 41. On information and belief, defendant Ordriin has indirectly infringed and continues to  
6 indirectly infringe one or more valid and enforceable claims of the '077 patent, in violation of  
7 35 U.S.C. § 271(b), by actively, knowingly, and intentionally inducing direct infringement by  
8 other persons, by making, using, offering for sale or license and/or selling or licensing  
9 infringing systems, products, and/or services in the United States without authority or license  
10 from Ameranth, including but not limited to the Ordriin Products.

11 42. On information and belief, systems including one or more of the Ordriin Products, as  
12 deployed and/or used at or from one or more locations by Ordriin, its agents, distributors,  
13 partners, affiliates, licensees, and/or their customers, infringe one or more valid and  
14 enforceable claims of the '077 patent, by, *inter alia*, doing at least one of the following: (a)  
15 Configuring and transmitting menus in a system including a central processing unit, a data  
16 storage device, a computer operating system containing a graphical user interface, one or more  
17 displayable master menus, menu configuration software enabled to generate a menu  
18 configuration for a wireless handheld computing device in conformity with a customized  
19 display layout, and enabled for synchronous communications and to format the menu  
20 configuration for a customized display layout of at least two different wireless handheld  
21 computing device display sizes, and/or (b) Enabling ordering and other hospitality functions  
22 via iPhone, Android, and other internet-enabled wireless handheld computing devices as well  
23 as via Web pages, storing hospitality information and data on at least one database, on at least  
24 one wireless handheld computing device, and on at least one Web server and Web page, and  
25 synchronizing applications and data, including but not limited to applications and data relating  
26 to orders, between at least one database, wireless handheld computing devices, and at least one  
27 Web server and Web page; utilizing communications control software enabled to link and  
28 synchronize hospitality information between at least one database, wireless handheld

1 computing device, and web page, to display information on web pages and on different  
2 wireless handheld computing device display sizes, and to allow information to be entered via  
3 Web pages, transmitted over the internet, and automatically communicated to at least one  
4 database and to wireless handheld computing devices; allowing information to be entered via  
5 wireless handheld computing devices, transmitted over the internet, and automatically  
6 communicated to at least one database and to Web pages.

7 43. On information and belief, customers of Ordriin, including consumers and restaurant  
8 operators, use the Ordriin Products in a manner that infringes upon one or more valid and  
9 enforceable claims of the '077 patent. Ordriin provides instruction and direction regarding the  
10 use of the Ordriin Products and advertises, promotes, and encourages the use of the Ordriin  
11 Products.

12 44. On information and belief, Defendant actively induces others to infringe the '077  
13 patent in violation of 35 U.S.C. §271(b) by knowingly encouraging, aiding and abetting  
14 customers of Ordriin, including consumers and restaurant operators, to use the infringing Ordriin  
15 Products in the United States without authority or license from Ameranth.

16 45. On information and belief, Defendant contributorily infringes and continues to  
17 contributorily infringe one or more valid and enforceable claims of the '077 patent, in violation  
18 of 35 U.S.C. § 271(c) by offering to sell and/or selling components of systems on which claims  
19 of the '077 patent read, constituting a material part of the invention, knowing that the  
20 components were especially adapted for use in systems which infringe claims of the '077  
21 patent.

22 46. By distributing, selling, offering, offering to sell or license and/or selling or licensing  
23 the Ordriin Products, Defendant provides non-staple articles of commerce to others for use in  
24 infringing systems, products, and/or services. Additionally, Ordriin provides instruction and  
25 direction regarding the use of the Ordriin Products and advertises, promotes, and encourages the  
26 use of the Ordriin Products. Users of the Ordriin Products directly infringe one or more valid  
27 and enforceable claims of the '077 patent, for the reasons set forth hereinabove.

1 47. On information and belief, Ordriin has had knowledge of the '077 patent, including  
2 knowledge that the Ordriin Products, which are non-staple articles of commerce, have been  
3 used as a material part of the claimed invention of the '077 patent, and that there are no  
4 substantial non-infringing uses for the Ordriin Products.

5 48. On information and belief, the aforesaid infringing activities of defendant Ordriin  
6 have been done with knowledge and willful disregard of Ameranth's patent rights, making this  
7 an exceptional case within the meaning of 35 U.S.C. § 285.

8 49. The aforesaid infringing activity of defendant Ordriin has directly and proximately  
9 caused damage to plaintiff Ameranth, including loss of profits from sales it would have made  
10 but for the infringements. Unless enjoined, the aforesaid infringing activity will continue and  
11 cause irreparable injury to Ameranth for which there is no adequate remedy at law.

12 **PRAYER FOR RELIEF**

13 WHEREFORE, plaintiff Ameranth respectfully prays for judgment against Defendant,  
14 as follows:

15 1. Adjudging that the manufacture, use, offer for sale or license and /or sale or  
16 license of the Ordriin Products indirectly infringes valid and enforceable claims of the '850  
17 patent, and the '325 patent, and the '077 patent, as set forth hereinabove;

18 2. Adjudging that Defendant has infringed, actively induced others to infringe  
19 and/or contributorily infringed valid and enforceable claims of the '850 patent, and the '325  
20 patent, and the '077 patent, as set forth hereinabove;

21 3. Adjudging that Defendant's indirect infringement of the valid and enforceable  
22 claims of the '850 patent, and the '325 patent, and the '077 patent, has been knowing and  
23 willful;

24 4. Enjoining Defendant, and its officers, directors, employees, attorneys, agents,  
25 representatives, parents, subsidiaries, affiliates and all other persons acting in concert,  
26 participation or privity with Defendant, and their successors and assigns, from infringing,  
27 contributorily infringing and/or inducing others to infringe the valid and enforceable claims of  
28 the '850 patent, and the '325 patent, and the '077 patent;
