

PATENT ALLEGATIONS

- 43. On December 17, 1991, the United States Patent and Trademark Office issued United States Patent No. 5,072,841 (the '841 Patent") for plastic containers naming Dr. Aziz Okhai as inventor and Norderney Investments Limited as assignee. A true and correct copy of the '841 Patent is attached hereto as Exhibit "A."
- 44. The '841 Patent and the rights to recovery thereunder have been assigned to NAC.

 NAC owns the rights to enforce the '841 Patent and to receive any damages due from infringement of the Patent.

COUNT I - PATENT INFRINGEMENT

- 45. Upon information and belief, Defendants have each infringed and continue to infringe the '841 Patent, either directly or indirectly through acts of contributory infringement or inducement, in violation of 35 U.S.C. § 271 et seq. by making, selling, offering to sell, and/or using plastic PET containers embodying the patented invention without license.
- 46. Upon information and belief, Defendants have known of the '841 Patent and Defendants' infringement of the '841 Patent has been and will continue to be willful.
- 47. Upon information and belief, Defendants will continue to infringe the '841 Patent unless and until restrained by the Court.
- 48. NAC has been damaged in an amount to be proved at trial and which should be trebled based on Defendants' willful conduct. NAC has also been irreparably injured by Defendants' infringement, and will continue to be damaged and irreparably injured unless Defendants' infringement is enjoined by the Court.

JURY DEMAND

49. Pursuant to Rule 38(b) of the Federal Rules of Civil Procedure, NAC hereby demands a jury on all issues triable of right by a jury.

WHEREFORE, PREMISES CONSIDERED, NAC respectfully demands judgment against Defendants as follows:

- a) Finding that Defendants have infringed, and in all likelihood will continue to infringe, United States Patent No. 5,072,841.
- b) Finding that such infringement has been willful.
- c) Finding that this is an exceptional case as defined in 35 U.S.C. § 271 et seq.

- d) Awarding NAC compensatory damages caused by Defendants' infringement of United States Patent No. 5,072,841 in an amount to be determined at trial, and then trebled.
- e) Awarding NAC the full costs of suit, NAC's reasonable attorneys' fees, and pre-judgment and post-judgment interest.
- f) Ordering that Defendants and their officers, employees, agents and all persons in active concert or participation with any of them be enjoined from continued infringement of United States Patent No. 5,072,841.
- g) Ordering that Defendants destroy all infringing bottles and containers in their possession and destroy all machinery, fixtures and the like used for manufacturing those bottles and containers.
- h) Such other and further relief as this Court or a jury may deem proper and just.
