FIRST AMENDED COMPLAINT

Plaintiff Round Rock Research, LLC ("Round Rock"), for its First Amended Complaint against Defendant Dole Food Company, Inc. ("Dole Food"), hereby alleges as follows:

Upon information and belief, discovery is likely to show that third parties, including Dole Food's customers, have infringed, and continue to infringe, one or more claims of the '674 patent under 35 U.S.C. § 271(a), either literally and/or under the doctrine of equivalents, by making, using, selling, and/or offering for sale in the United States, and/or importing into the United States, RFID products supplied at least in part by Dole Food.
- 102. Dole Food has had knowledge of and notice of the '674 patent and its infringement since at least December 22, 2010, through a letter sent by Round Rock to Dole Food concerning the '674 patent and its infringement.
- 103. Upon information and belief, discovery is likely to show that Dole Food has induced infringement, and continues to induce infringement, of one or more claims of the '674 patent under 35 U.S.C. § 271(b). Dole Food actively, knowingly, and intentionally induced, and

continues to actively, knowingly, and intentionally induce, infringement of the '674 patent by selling or otherwise supplying RFID products; with the knowledge and intent that third parties will use, sell, offer for sale, import, and/or make a communication system with, the RFID products supplied by Dole Food to infringe the '674 patent; and with the knowledge and intent to encourage and facilitate the infringement through the dissemination of the RFID products and/or the creation and dissemination of promotional and marketing materials, supporting materials, instructions, product manuals, and/or technical information related to the RFID products.

- 104. Upon information and belief, discovery is likely to show that Dole Food has contributed to the infringement by third parties, including Dole Food's customers, and continues to contribute to infringement by third parties, of one or more claims of the '674 patent under 35 U.S.C. § 271(c), by selling and/or offering for sale in the United States, and/or importing into the United States, RFID products, knowing that those products constitute a material part of the inventions of the '674 patent, knowing that those products are especially made or adapted to infringe the '674 patent, and knowing that those products are not staple articles of commerce suitable for substantial noninfringing use.
- 105. Round Rock has been and continues to be damaged by Dole Food's infringement of the '674 patent.
 - 106. Dole Food's infringement of the '674 patent was, and continues to be, willful.
- 107. Dole Food's conduct in infringing the '674 patent renders this case exceptional within the meaning of 35 U.S.C. § 285.

Infringement Of The '562 Patent

- 109. The '562 patent is valid and enforceable.

Dole Food has infringed, and continues to infringe, one or more claims of the '562 patent under 35 U.S.C. § 271(a), either literally and/or under the doctrine of equivalents, by making, using, selling, and/or offering for sale in the United States, and/or importing into the United States, products and/or methods encompassed by those claims, including for example, by making, using, selling, offering for sale, and/or importing RFID products.
- 111. Upon information and belief, discovery is likely to show that third parties, including Dole Food's customers, have infringed, and continue to infringe, one or more claims of the '562 patent under 35 U.S.C. § 271(a), either literally and/or under the doctrine of equivalents, by making, using, selling, and/or offering for sale in the United States, and/or importing into the United States, RFID products supplied at least in part by Dole Food.
- 112. Dole Food has had knowledge of and notice of the '562 patent and its infringement since at least December 22, 2010, through a letter sent by Round Rock to Dole Food concerning its infringement of U.S. Patent No. 6,545,604, the patent from which the '562 patent reissued.
- 113. Upon information and belief, discovery is likely to show that Dole Food has induced infringement, and continues to induce infringement, of one or more claims of the '562 patent under 35 U.S.C. § 271(b). Dole Food actively, knowingly, and intentionally induced, and continues to actively, knowingly, and intentionally induce, infringement of the '562 patent by selling or otherwise supplying RFID products; with the knowledge and intent that third parties will use, sell, offer for sale, import, and/or make a communication system with, the RFID products supplied by Dole Food to infringe the '562 patent; and with the knowledge and intent to encourage and facilitate the infringement through the dissemination of the RFID products and/or

the creation and dissemination of promotional and marketing materials, supporting materials, instructions, product manuals, and/or technical information related to the RFID products.

- 114. Upon information and belief, discovery is likely to show that Dole Food has contributed to the infringement by third parties, including Dole Food's customers, and continues to contribute to infringement by third parties, of one or more claims of the '562 patent under 35 U.S.C. § 271(c), by selling and/or offering for sale in the United States, and/or importing into the United States, RFID products, knowing that those products constitute a material part of the inventions of the '562 patent, knowing that those products are especially made or adapted to infringe the '562 patent, and knowing that those products are not staple articles of commerce suitable for substantial noninfringing use.
- 115. Round Rock has been and continues to be damaged by Dole Food's infringement of the '562 patent.
 - 116. Dole Food's infringement of the '562 patent was, and continues to be, willful.
- 117. Dole Food's conduct in infringing the '562 patent renders this case exceptional within the meaning of 35 U.S.C. § 285.

Prayer For Relief

WHEREFORE, Round Rock prays for judgment as follows:

- A. That Dole Food has infringed each of the patents-in-suit;
- B. That Dole Food's infringement of each of the patents-in-suit has been willful;
- C. That Round Rock be awarded all damages adequate to compensate it for Dole Food's infringement of the patents-in-suit, such damages to be determined by a jury and, if necessary to adequately compensate Round Rock for the infringement, an accounting, and that

such damages be trebled and awarded to Round Rock with pre-judgment and post-judgment interest;

- D. That this case be declared an exceptional case within the meaning of 35 U.S.C. § 285 and that Round Rock be awarded the attorney fees, costs, and expenses that it incurs prosecuting this action; and
- E. That Round Rock be awarded such other and further relief as this Court deems just and proper.

Demand For Jury Trial

Plaintiff Round Rock hereby demands a trial by jury on all issues so triable.
