1. The Order and final judgment entered on January 12, 2012 (D.I. 630);
2. The Order on Parallel Networks’ Motion to Alter or Amend This Court’s Summary Judgment Order Under Rule 59(e), F.R.C.P., entered on December 5, 2011 (D.I. 619);
3. The Orders denying Parallel Networks’ Motion to Alter or Amend This Court’s Summary Judgment Order Under Rule 59(e), F.R.C.P., and granting defendants’ motion for entry of final judgment at the hearing on November 29, 2011 (*see* D.I. 623 (minutes of hearing); transcript of the hearing not yet docketed);
