

7 NATURE OF THE ACTION

8 37. In this civil action, Plaintiffs seek damages against Defendants for acts of
9 patent infringement in violation of the Patent Act of the United States, 35 U.S.C. §§ 1
10 et seq.

11 JURISDICTION AND VENUE

12 38. This Court has subject matter jurisdiction of such federal question claims
13 pursuant to 28 U.S.C. §§ 1331 and 1338(a).

14 39. Venue is proper under 28 U.S.C. §§ 1391(c) and 1400(b), in that the acts
15 and transactions complained of herein were conceived, carried out, made effective, or
16 had effect within the State of California and within this district, among other places.
17 On information and belief, Defendants conduct business activities in this judicial
18 district including regularly doing or soliciting business, engaging in conduct and/or
19 deriving substantial revenue from goods and services provided to consumers in the
20 State of California and in this district. Furthermore, certain of the Defendants are
21 registered to do business with the California Secretary of State.

22 40. On information and belief, this Court has personal jurisdiction over the
23 Defendants. Each of the Defendants conducts continuous and systematic business in
24 California and in this district by offering to sell and/or selling mobile devices and/or
25 3G wireless services in this State in this district.

26 41. Defendants are properly joined in this action because (1) GBT's right to
27 relief is asserted against certain Defendants jointly and severally which have a parent
28

1 and subsidiary relationship, (2) infringing acts of Defendants arise out of the same
2 transaction, occurrence or series of transactions or occurrences relating to the making,
3 using, offering for sale, and selling of the accused products in this action, and (3)
4 questions of fact common to all Defendants will arise in the action. More specifically,
5 on information and belief, each of the Defendants' accused products and methods use
6 one of two common baseband processors designed and manufactured by Intel
7 Corporation (formerly Infineon Corporation) and Qualcomm, Inc. to practice the
8 claimed inventions. The two baseband processors used in all the accused devices
9 operate sufficiently identically to comply with an international telecommunications
10 standard for 3G wireless communications known as the UMTS 3GPP standard. The
11 claims of the '793 patent that Plaintiff will assert all read on the UMTS 3GPP
12 standard, such that infringement in this case can be proven by establishing that (i) the
13 accused devices satisfy the UMTS 3GPP standard (which defendants all claim to
14 satisfy) and (ii) the asserted claims of the '793 patent read on the standard. For these
15 reasons, infringement issues in this case will uniformly focus for all defendants on
16 one or two common baseband processors, resulting in substantial evidentiary overlap
17 in the design and operation of the accused devices, as applied to the claims of the '793
18 patent.

19 **BACKGROUND OF THE DEVELOPMENT OF 3G WIRELESS NETWORKS**

20 42. The efficiency and quality of the wireless communication networks have
21 seen extraordinary improvements over the past few decades. Although prototypes of
22 cell phones existed as early as the 1940s, cell phones were not commercially marketed
23 in the United States until the early 1980s. The first cell phone cost almost \$4,000 per
24 unit and operated on an analog network (also known as the First Generation or "1G"
25 network). Analog networks were notoriously slow and users of the analog networks
26 often experienced distorted voices and call interferences.

1 43. In the early 1990s, a set of standards defining the Second Generation or
2 "2G" network was introduced. The 2G digital network came with many advantages
3 including increasing the capacity of the telecommunications system by allowing
4 digital voice calls to be compressed, thereby using available bandwidth more
5 efficiently. The 2G network also allowed data transmission, enabling users to
6 transmit text messages from one mobile phone to another mobile phone.

7 44. Continued improvements to the 2G network were made, including, for
8 example, the 2.5G network and the 2.75G (EDGE) network, both of which improved
9 upon the abilities to use mobile phones to receive and transmit more advanced types
10 of data including photos, email and the internet.

11 45. Today, the third generation of wireless network standards, also known as
12 "3G", has been widely deployed and is currently in use. A 3G compliant network
13 provides high speed bandwidth to handheld devices, including mobile phones, as well
14 as other types of transmission/reception devices such as electronic readers, "smart
15 phones", and laptop cards. The 3G network expands the utility of wireless phones
16 and other 3G compatible devices because it allows users to conduct tasks more
17 quickly than in the past, including viewing video, downloading books and magazines,
18 sending and receiving text and multimedia messages, as well as making and receiving
19 voice calls. The advent of the 3G network allows users to watch mobile TV on
20 demand, conduct video conferencing, and utilize location based services which allows
21 users to find businesses or contacts nearby. 3G also allows users to simultaneously
22 use voice and data services, allowing user to browse the internet and conduct a voice
23 call at the same time from the same device.

24 **THE GLOBAL STANDARDIZATION OF 3G NETWORKS**

25 46. 3G is a compilation of technologies, the standards for which are
26 articulated by the International Telecommunication Union ("ITU"), a global standards
27 setting organization. The ITU, through the International Mobile Telecommunications-

1 2000 (IMT-2000) initiative mandated the necessity of, and the requirements for, a
2 single global wireless standard. Many groups and committees worked together to
3 develop mobile phone systems that are compliant with IMT-2000. Those groups
4 included the Telecommunications Industry Association ("TIA") and the European
5 Telecommunications Standards Institute ("ETSI").

6 47. In or around late 1998, various regional standards organizations and
7 committees, including ETSI, formed a standards setting group with the purpose of
8 creating uniform standards for 3G wireless networks and the Wideband Code
9 Division Multiple Access/Universal Mobile Telecommunications System (known as
10 WCDMA/UMTS or sometimes just UMTS) that were compliant with the IMT-2000.
11 This standards setting organization was named the Third Generation Partnership
12 Project ("3GPP").

13 48. Currently, all 3G networks claiming to be UMTS compliant must comply
14 with the IMT-2000 global initiative as articulated by 3GPP.

15 49. UMTS improved upon previous platforms by efficiently supporting
16 increased speeds and capacity, thereby allowing even more robust uses of mobile
17 devices.

18 **GBT'S CONTRIBUTIONS TO THE TELECOMMUNICATIONS**
19 **STANDARDS REQUIRED BY THE IMT-2000 AND ARTICULATED BY**
20 **3GPP FOR 3G NETWORKS**

21 50. GBT's '793 patent, also known as the "Multicode patent," relates to 3G
22 compliant mobile devices utilizing UMTS compliant technology.

23 51. The technology claimed in the '793 patent was developed by GBT, an
24 innovator in the mobile telecommunications field.

25 52. Founded in 1995, GBT was formed for the purpose of developing
26 wireless solutions. Originally, GBT focused upon developing solutions relating to
27 making wireless connections to broadband data networks.

1 53. GBT assisted in developing wireless solutions in the wireless
2 marketplace and certain wireless technologies, including a wireless multi-media
3 service using GBT's technology known as Code Division Multiple Access technology
4 or "GB-CDMA". GBT also co-chaired a standardization committee that developed
5 3G technologies.

6 54. In 1998, after the announcement that 3G would be standardized based on
7 UMTS, GBT invested additional resources designed to make the 3G UMTS
8 environment more efficient and faster.

9 55. In 2001, many of GBT's technical innovations and contributions were
10 ultimately adopted by 3GPP as an important and necessary part of the 3G and UMTS
11 standards. 3GPP articulated these global standards in several documents, including
12 one document entitled "3GPP; Technical Specification Group Radio Access Network;
13 Physical Layer Procedures (FDD)", of which there have been several releases.

14 56. GBT's contributions to the 3G UMTS global standards greatly enhanced
15 the efficiency with which data could be transmitted and was integral in enabling rapid,
16 efficient connections of UMTS compliant mobile devices to a UMTS compliant 3G
17 network.

18 57. As a result of being adopted as part of the standard for 3G and UMTS,
19 certain of GBT's technology is necessarily required for any use of a 3G UMTS
20 compliant mobile device.

21 58. GBT, desiring to protect its technology, sought patents from the United
22 States Patent and Trademark Office.

23 59. On February 6, 1998, GBT filed the '793 patent application and on June
24 13, 2000, the United States Patent & Trademark Office duly and legally issued United
25 States Letters Patent No. 6,075,793 entitled "HIGH EFFICIENCY SPREAD
26 SPECTRUM SYSTEM AND METHOD". A true and correct copy of the '793 patent
27 is attached hereto as Exhibit 1 and incorporated herein by reference.

1 60. The '793 patent describes a multichannel-spread-spectrum system for
2 communicating a plurality of data -sequence signals from a plurality of data channels
3 using parallel chip-sequence signals in which fewer than all of the channels include
4 header information. A header device concatenates a header to a first data sequence
5 signal on a first channel. Data -sequence signals in parallel channels are sent without
6 a header, and are timed from the header in the first channel. By sending data through
7 parallel spread-spectrum channels, while including headers in fewer than all of the
8 channels, the invention increases data transmission efficiency.

9 61. The '793 patent claims certain of GBT's contributions to the 3G UMTS
10 standards required by the IMT-2000 and articulated by 3GPP.

11 **DEFENDANT APPLE'S UNAUTHORIZED USE**
12 **OF THE MULTICODE PATENT**

13 62. Apple is a leader in providing user-friendly mobile devices to the public.
14 Apple's most well-known products include mobile music players, personal computers
15 and laptops, and the iPhone.

16 63. The iPhone, first introduced in 2007, provided users easy access to an
17 interface which allowed users to not only make phone calls easily but also to play
18 games, take and send photographs, play music, among other functions.

19 64. On June 11, 2008, Apple released the iPhone 3G, which utilizes UMTS
20 compliant technology. The iPhone 3G supports faster 3G data speeds via UMTS
21 compliant technology and quickly became a favorite among wireless services
22 subscribers.

23 65. In 2009, Apple released the iPhone 3GS, which continues to operate on
24 UMTS compliant 3G networks but sported upgrades and improvements, including a
25 video camera, as compared to the iPhone 3G.

26 66. To date, Apple continues to make, offer for sale, and sell mobile devices
27 that are specifically configured to operate on UMTS compliant 3G wireless networks,

1 including the Apple iPhone 3G, the iPhone 3GS, and versions of a mobile reader with
2 a 3G 4G connectivity option marketed as the Apple iPad. Millions of the iPhones and
3 iPads are active in the U.S. alone and the iPhone and iPad continue to increase in
4 popularity.

5 67. At least as early as April 15, 2009, GBT contacted Apple by letter,
6 informing Apple that certain of GBT's patented technology was required by the
7 standard articulated by 3GPP, and offering Apple the opportunity to license GBT's
8 patents. Apple has not, to date, taken a license or otherwise obtained GBT's
9 permission to use GBT's patented technology.

10 **DEFENDANT MOTOROLA'S UNAUTHORIZED USE**

11 **OF THE MULTICODE PATENT**

12 68. Defendant Motorola is a Fortune 100 telecommunications company
13 based in Schaumburg, Illinois. It is a manufacturer of cellular phones, as well as many
14 other products.

15 69. Motorola makes, sells, offers for sale and/or imports certain mobile
16 stations which are configured to allow connection to 3G UMTS compliant wireless
17 networks. Those mobile stations manufactured by Motorola that are configured to
18 allow connection to UMTS compliant 3G wireless networks include the Motorola
19 Tundra, Backflip, Karma, and Cliq XT devices.

20 70. At least as early as April 15, 2009, GBT contacted Motorola by letter,
21 informing Motorola that certain of GBT's patented technology was required by the

24 71. Motorola has not, to date, taken a license or otherwise obtained GBT's
25 permission to use GBT's patented technology.

20 offered for sale and/or imported by Barnes & Noble that are configured to allow
21 connection to 3G UMTS compliant wireless networks include the Barnes & Noble e-
