**GEMSTAR’S NOTICE OF APPEAL**

NOTICE is hereby given that Cross-Claim Plaintiffs TVG-PMC, Inc., StarSight Telecast, Inc., and Gemstar-TV Guide International, Inc. (collectively “Gemstar”) hereby appeal as of right to the United States Court of Appeals for the Federal Circuit from:

- Judgment entered on May 18, 2011, dismissing Gemstar’s declaratory judgment action against Plaintiff Personalized Media Communications, LLC (“PMC”) for lack of subject matter jurisdiction (Docket No. 665);

- Judgment entered on May 18, 2011, in favor of PMC against Gemstar on Gemstar's breach of contract claim (Docket No. 667);
- Order entered on May 18, 2011, directing entry of final judgment in favor of PMC against Gemstar on Gemstar's breach of contract claim (Docket No. 666);
- Order entered on May 18, 2011, to the extent it denies Gemstar's Motion for Reconsideration and reaffirms the Court's holding that Gemstar's declaratory judgment claim is moot (Docket No. 664); and
- Order entered on December 14, 2010, to the extent that it grants PMC's Motion to Dismiss for Lack of Subject Jurisdiction, reflects the Court's holding that Gemstar's declaratory judgment claim is moot and dismisses Gemstar's declaratory judgment claim (Docket No. 636).
