**PLAINTIFF POWER INTEGRATIONS' NOTICE OF APPEAL**

Pursuant to the Federal Rules of Civil Procedure and the Federal Rules of Appellate Procedure, plaintiff Power Integrations, Inc. ("Power Integrations") hereby appeals to the United States Court of Appeals for the Federal Circuit from the following:

The December 12, 2008 Order granting-in-part Fairchild's motion for remittitur and reducing the Jury's damages award by 82% (D.I. 695);

The December 12, 2008 Order denying Power Integrations' motion for an accounting (D.I. 696);

The June 2, 2006 Order precluding Power Integrations from relying on information before October 20, 2004 for purposes of the calculation of damages attributable to Fairchild's infringement in this case (D.I. 265) and the Court's subsequent Order of August 22, 2006 denying Power Integrations' request for reconsideration on this issue (D.I. 329).

The amount of compensatory damages awarded in the final judgment as entered on January 26, 2011 (D.I. 798) and corrected on February 3, 2011 (D.I. 800), to the extent the final judgment carried through and reflected the errors noted above in the underlying orders, decisions, and rulings of the Court regarding Power Integrations' entitlement to damages attributable to Fairchild's infringement of Power Integrations' patents.
