Spread Spectrum Screening LLC does not appeal the portions of Court’s Order (i) severing “the claims against Kodak and the Kodak Customers (Continental, Graphic, Genesis, and Johns-Byrne) from the claims against Heidelberg and Hafner;” and (ii) transferring “venue to the Western District of New York with respect to plaintiff’s action against Kodak.”
