24 This is an action for patent infringement in which DIGITECH IMAGE
25 TECHNOLOGIES, LLC submits this Original Complaint against the Defendants
26 named herein, namely TOSHIBA CORPORATION; TOSHIBA AMERICA, INC.;
27 TOSHIBA AMERICA BUSINESS SOLUTIONS, INC. and TOSHIBA AMERICA

1 INFORMATION SYSTEMS, INC. (collectively “Defendants” or “TOSHIBA”), as

4 **THE PARTIES**

5 1. DIGITECH IMAGE TECHNOLOGIES, LLC (“DIGITECH” or
6 “Plaintiff”) is a California limited liability company with a place of business at 500
7 Newport Center Drive, Suite 700, Newport Beach, CA 92660.

9 2. On information and belief, TOSHIBA CORPORATION is a foreign
10 company with a place of business at Tokyo, Japan and TOSHIBA AMERICA, INC.,
11 TOSHIBA AMERICA BUSINESS SOLUTIONS, INC. and TOSHIBA AMERICA
12 INFORMATION SYSTEMS, INC. are Delaware, California and California
13 corporations, respectively, with places of business at New York, NY, Irvine, CA and
14 Irvine, CA respectively.

15 to this Court's specific and/or general personal jurisdiction, pursuant to due process
16 and/or the California Long Arm Statute, due at least to its substantial business in this
17 district, including related to the infringements alleged herein. Further, on information
18 and belief, TOSHIBA has, within this forum, engaged in at least the selling of the
19 accused products listed herein. In addition, TOSHIBA induces infringement of the
20 patent-in-suit by sellers and/or infringing users located in this forum. Further, on

4 **COUNT I**

5 **INFRINGEMENT OF U.S. PATENT NO. 6,128,415**

6 6. United States Patent No. 6,128,415 (“the ‘415 patent”), entitled
7 “DEVICE PROFILES FOR USE IN A DIGITAL IMAGE PROCESSING
8 SYSTEM,” issued on October 3, 2000.

9
10 7. DIGITECH is the present assignee of the entire right, title and interest in
11 and to the ‘415 patent, including all rights to sue for past and present infringement and
12 to recover all damages therefor. Accordingly, DIGITECH has standing to bring this
13 lawsuit for infringement of the ‘415 patent.

14
15 8. The various claims of the ‘415 patent cover, *inter alia*, a device profile
16 for describing properties of a device in a digital image reproduction system to capture,
17 transform or render an image, said device profile comprising: first data for describing
18 a device dependent transformation of color information content of the image to a
19 device independent color space; and second data for describing a device dependent
20 transformation of spatial information content of the image in said device independent
21 color space.

22
23 9. On information and belief, TOSHIBA has been and now is infringing the
24 ‘415 patent by actions comprising making, using, importing, selling and/or offering to
25

1 sell products comprising a device profile for describing properties of a device in a
2 digital image reproduction system to capture, transform or render an image, said
3 device profile comprising: first data for describing a device dependent transformation
4 of color information content of the image to a device independent color space; and
5 second data for describing a device dependent transformation of spatial information
6 content of the image in said device independent color space.
7
8

9 10. DIGITECH reserves the right to take discovery regarding TOSHIBA's
10 prior notice regarding the '415 patent. On information and belief, once TOSHIBA
11 received notice of the '415 patent, at a minimum by virtue of this suit, its actions
12 necessarily constitute active inducement of resellers and/or users who are known to
13 perform infringing sales, offers for sale and/or uses of TOSHIBA's infringing
14 products. Such inducement necessarily involves TOSHIBA's intent to induce such
15 infringement and/or knowledge of at least a high probability that the infringing acts
16 that it aids, abets and/or encourages constitute infringement of the '415 patent.

20 11. Upon present information and belief, TOSHIBA's infringing products
21 comprise at least the following accused products: e-STUDIO2040C, e-

5 12. TOSHIBA is thus liable for infringement of the '415 patent pursuant to
6 35 U.S.C. § 271.
7

8 13. As a result of TOSHIBA's infringing conduct, TOSHIBA has damaged
9 DIGITECH. TOSHIBA is liable to DIGITECH in an amount that adequately
10 compensates DIGITECH for its infringement, which, by law, can be no less than a
11 reasonable royalty.
12

13 14. On information and belief, TOSHIBA has at least had constructive notice
14 of the '415 patent by operation of law.
15

16 **PRAYER FOR RELIEF**

17 WHEREFORE, DIGITECH respectfully requests that this Court enter:
18

19 1. A judgment in favor of DIGITECH that TOSHIBA has infringed,
20 directly and/or indirectly, the '415 patent;
21

22 2. A judgment that TOSHIBA's infringement is and/or has been willful and
23 objectively reckless;
24

25 3. A permanent injunction enjoining TOSHIBA, and its officers, directors,
26 employees, agents, affiliates and all others acting in active concert therewith from
27 infringing the '415 patent;

4. A judgment and order requiring TOSHIBA to pay DIGITECH its damages, costs, expenses, and prejudgment and post-judgment interest for TOSHIBA's infringement of the '415 patent as provided under 28 U.S.C. § 284;

5. An award to DIGITECH for enhanced damages as provided under 35 U.S.C. § 284;

6. A judgment and order finding that this is an exceptional case within the meaning of 35 U.S.C. § 285 and awarding to DIGITECH its reasonable attorneys' fees;

7. Any and all other relief to which DIGITECH may show itself to be entitled.

DEMAND FOR JURY TRIAL

Plaintiff, under Rule 38 of the Federal Rules of Civil Procedure, requests a trial by jury of any issues so triable by right.
